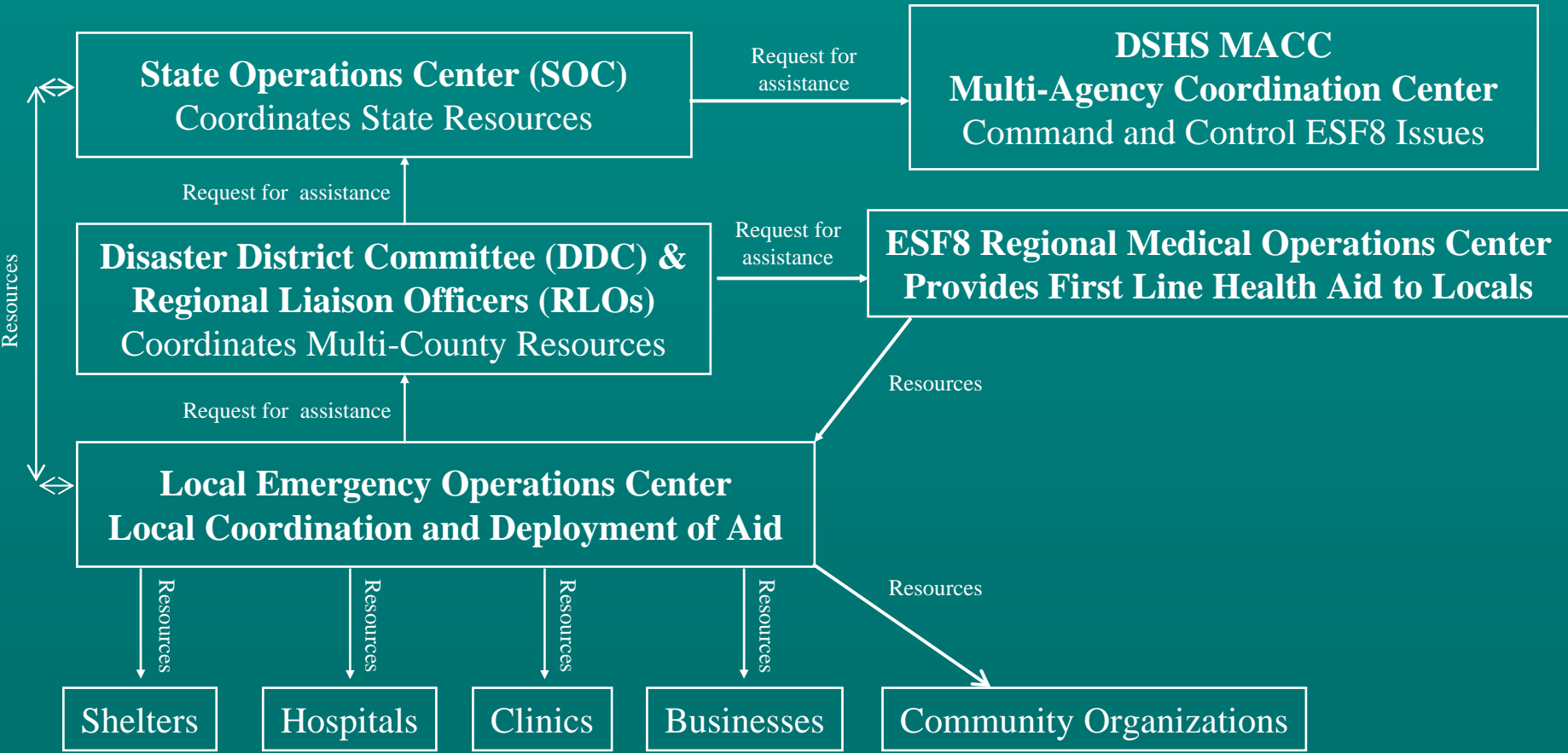

Keys to Effective Public Health Preparedness

- **All hazards planning at all levels - state, regional, local government, business, family**
 - Texas Homeland Security Strategic Plan
- **Training & exercises**
 - Planning alone is insufficient
- **Integration at all levels**
 - Local officials must be supported at regional, state & national levels
 - Support local health department capacity
- **Coordinated communications**
- **Community and family preparedness**

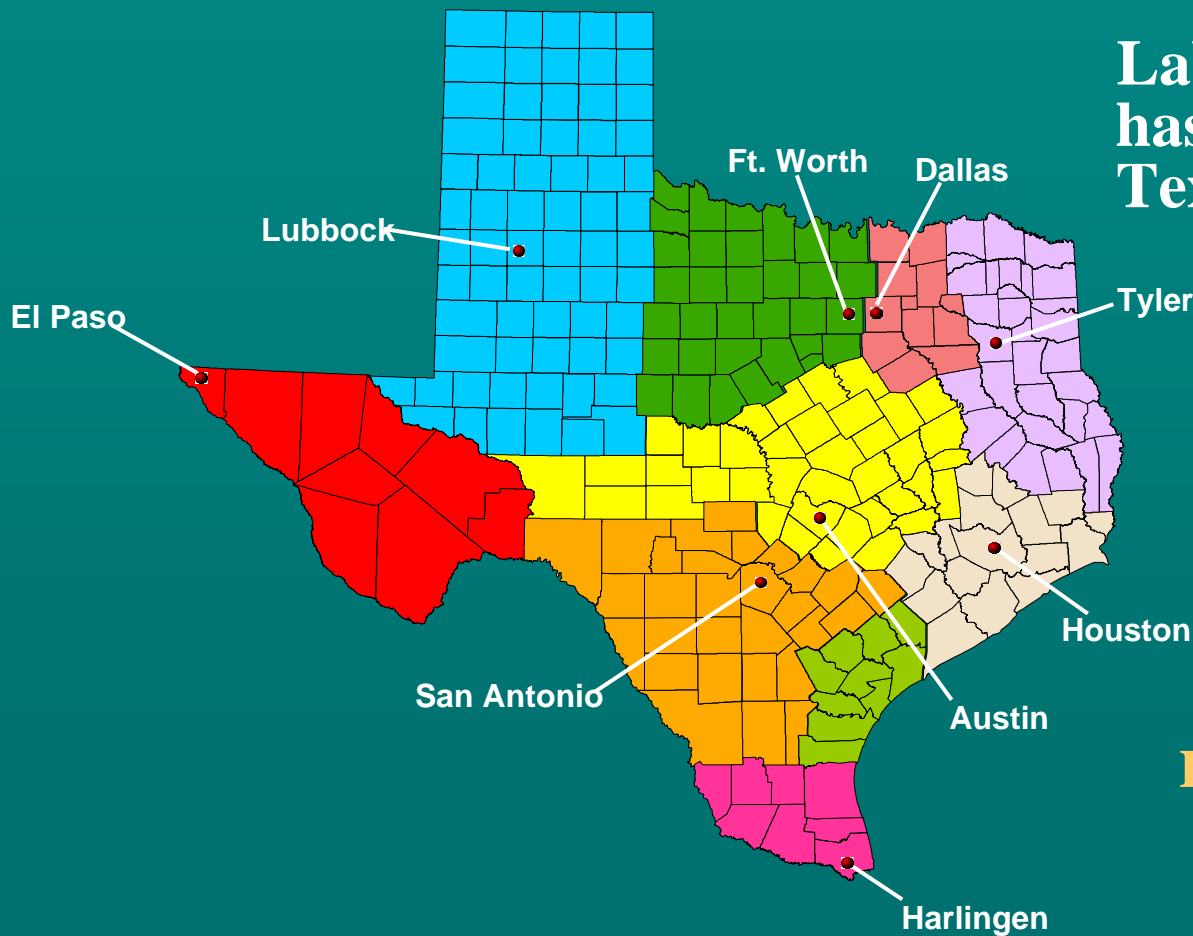
Successes in Public Health Preparedness

- CDC rated Texas' SNS readiness and ability at 97
- CDC recommended other states adopt Texas Pan Flu Plans for communications and antiviral distribution
- Enhanced disease surveillance with primary care providers



- Coordination with CDC & others at ports of entry
- \$10 million GR for purchase of 677,000 antiviral courses

Medical Special Needs: Human Resources

- **Volunteers**

- Texas Volunteer Registry is web-based system to identify state medical & lay volunteers, and verify credentials, qualifications
- Developed to consider volunteer liability
- Launch by March 2008

- **Medical Reserve Corps:**

- A national network of doctors, nurses and other medical professionals who have volunteered to help respond to emergencies at the local level
- Currently, there are 24 MRCs in Texas

Medical Special Needs: Equipment

- **Jump Bags**: Created 150 Medical Special Needs “Jump Bags” to provide medical professionals with necessary medical equipment & supplies to care for MSN patients during evacuations
- **Push Packs**: Developed *Push Packs*” for shelters with necessary medical equipment & supplies to sustain 10,000 people for 3 days



Medical Special Needs: Shelters

- **Medical Special Needs HUBS**
 - 17 HUB Cities across Texas serve as reception points for all-hazard triage for medical care, shelter, and other needs



- **With CDC funds, DSHS is evaluating the purchase of trailers to create:**
 - Two 250-bed mobile medical special needs shelters
 - Two 100-bed mobile pediatric medical special needs shelters

Increased EMS Response Capacity

- DSHS is working to increase EMS response capacity to support local needs.
- Partnerships with neighboring states to share EMS resources across state lines.
- Texas can activate national contracts for ambulances and other vehicles to evacuate medical special needs individuals.

- **Size of Texas**
- **International Border with Mexico**

Challenges in Public Health Preparedness

- **Reductions in federal funding for public health preparedness**
 - **\$36 million in federal FY 2008 public health preparedness funding.**
 - **\$30 million in federal FY 2008 hospital preparedness funding.**
 - **Provides funds for state, regional and local preparedness activities.**
 - **Expected reduction of 10-12% in both funds for FY 2009.**
 - **Will work with stakeholders to plan/prioritize for expected reductions.**

Challenges in Public Health Preparedness

- **Unique characteristics of Pandemic Flu**
 - **Pervasive**
 - **Prolonged**
 - **COOP challenges**
 - **Social distancing strategies required**
 - **Laws governing social distancing policies may require legislative review**

Concluding Thoughts

- **We continue to make significant progress in our preparedness efforts**
- **We are partnering with not only federal, state & local governments and organizations, but also with private sector**
- **We must sustain public health capacity to effectively respond to any natural or man-made disaster**
- **We must manage critical funding challenges**
