Please remember that, with the adoption of the new Offender Education rules on September 1, 2009, ALL instructors for DWI Education, Drug Offender Education, DWI Intervention, and Alcohol Education Program for Minors ***must*** attend a DSHS Inservice ***during*** each 2 year certification period. Under TAC Rule § 453.105, instructors who are fully licensed chemical dependency counselors, licensed professional counselors, licensed psychologists, licensed psychiatrists, or licensed social workers may submit 20 hours of continuing education that is directly drug- (for DOEP instructors) or alcohol- (for DWIE, DWII, AEPM instructors) related and approved by the department's Offender Education Group at least 30 days in advance, in lieu of attending the in-service. (Please see the actual rule at [TAC 453.105](#) for more specifics.) This inservice also provides 20 courtesy CEUs for LPCs and LCDCs that may be used toward your licenses. Probation Officers must have their continuing education certificate approved by their chief to obtain hours. TCLEOSE has indicated they will also accept the continuing education hours for peace officers, with proper approval from your department.

This inservice will begin **promptly on Wednesday, February 5 at 8:30 am** and will conclude by **3:30 pm on Friday, February 7** for ALL INSTRUCTORS in ALL PROGRAMS. **All instructors must attend all three days.** In order to obtain credit for this inservice and the certificate of completion, all participants are required to be on time and complete all applicable sessions *in their entirety* -- **participants arriving late will not be credited with the inservice.** There are a number of eateries within walking distance of the college, as no food or drink can be provided, and you are also welcome to bring your own snacks and drinks. Please provide your email address on the registration form, as we will **only** confirm or provide new parking information via email. We also encourage you to bring a jacket to the inservice, as temperatures in the room may be cool and not easily controlled, as well as business cards for networking with other instructors. Parking is limited in the morning, and street parking is available, but you may have to walk if necessary. **Please observe posted parking signs. DO NOT PARK in the Garage or Faculty Parking or you will be towed.** You may park in any "open" or "student" lot without penalty.

Enrollment is limited and admittance will be based on a first-come-first-serve basis – when room capacity is reached, registration will be closed. The cost of the training is **\$100.00 for each type of inservice you are attending. All fees are non-refundable.** **A \$100 late fee will be applied to payments received after the deadline of January 22, 2014. DO NOT SUBMIT PAYMENT TO DEPARTMENT OF STATE HEALTH SERVICES—please follow the instructions below.** If a minimum number of registrations are not received, the inservice may be canceled; we recommend not making non-refundable travel arrangements or reservations.

Please complete the Registration Form and submit it to DSHS no later than January 22, 2014. Nonrefundable payments are to be submitted to The University of Texas at Austin along with the attached invoice, no later than January 22, 2014. If the registration form is not received by DSHS, you will not be registered or allowed into the inservice. Once your payment and registration form have been received by the appropriate agencies, you are considered registered. Absolutely no registrations or payments will be accepted after 5pm on Monday January 27, 2014. Attendance Policy: Because of accrediting agency guidelines, **partial credit will not be given.** To receive a certificate of completion and credit for the inservice(s), *all sessions* must be attended in their *entirety*, and participants must be on time each day.
