Registration should be completed no later than 5:00 p.m., Wednesday, June 2, 2021. Members of the public may also use the Microsoft Teams Live Event Q&A section during the meeting to submit a request to provide public comment. The request must contain your name and the organization you are representing, or that you are speaking as a private citizen as well as your direct phone number. Do not include confidential information or protected health information in comments.
