## **TxEVER Steps for Medical Certifier before a Funeral Home can print a Burial Transit Permit**

- Medical Certifier must login to TxEVER, accept the death record assigned to them, select "Natural" as the manner of death in Medical tab 2, then click save.
- Once the certifier has completed the above steps, the funeral home can print the Burial Transit Permit (BTP).
- The following slides illustrate how a medical certifier can complete the steps necessary to allow a funeral home to print a BTP.

#### Once the medical certifier receives an email on the new death record in their queue, the medical certifier logs into TxEVER and selects the location where the death record was assigned to them
