



Audit Finding from Review of 837 Test Submissions

The main audit failure for submissions continues to be that for physician. The reasons found for audit failure include the following:

- ❖ Incorrect UPIN,
- ❖ Name parsed incorrectly into name fields,
- ❖ UPIN reported not on THCIC Practitioner File.

Suggestions to reduce audit errors:

1. Use the state license number instead of the UPIN, and
2. Ensure that the name is being parsed correctly into the last, first and middle initial data elements.

In some cases, submitters are including both the state license number and the UPIN. THCIC uses the last occurrence, so if both are included, the state license number should be listed last.



Certification Data Release Schedule

Certification data is being released beginning March 1st. The data will be released over a period of three weeks. Quarter 1 certification data will be placed in hospital mailboxes on March 1st. Second quarter will be placed in mailboxes a week later on March 8th, and third quarter will be placed in mailboxes on March 15th.

In order to ease the download process, please retrieve the certification data within the seven-day window.

For Those That Will Receive only Third Quarter Data:

If you have already received your first and second quarter certification data, your third quarter data will be placed in your mailbox March 15th.

Those of you that receive your certification data on magnetic media will receive your data on the same or expedited schedule.

Certification Letters Due

Regardless of when you receive your certification data, certification letters for all three quarters are due June 1st and cutoff for corrections at certification is April 15th.

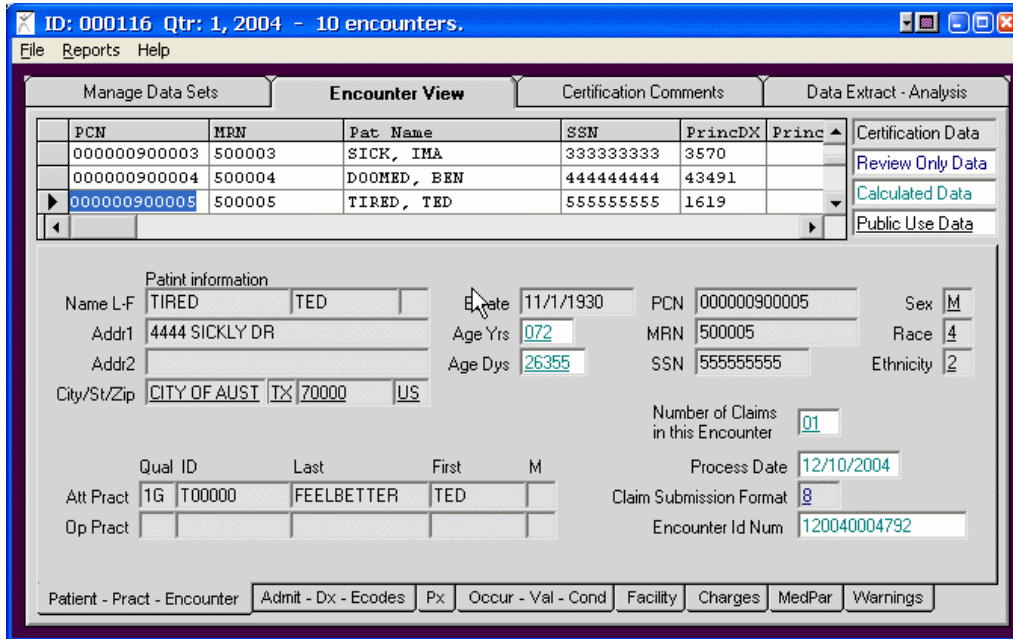
New CertView Software

Certification Software Update Release

The Certview software released for use for certification of 2004 data has printing issues when the software is installed on a system with other than Access 2000. Commonwealth is working at this time to correct this problem. A corrected version will be released no later than April 1st.

In addition, to accommodate the delay with release of the corrected version, the deadline for corrections at certification is being moved to April 30th. The due date for certification letters and comments remains at June 1st.

If you must have the reports before April 1st, you can request them, via email or voicemail, from the Commonwealth Help Desk. The reports will be generated and placed in your mailbox. You will be notified when the reports are ready.

Corrections at Certification Schedule Change

To accommodate the delay with release of the corrected version of the Certview software, the deadline for 1st, 2nd, and 3rd quarter 2004 corrections at certification is being moved from April 15th to April 30th. The due date for certification letters and comments remains at June 1st.

Contacting Help Desk

837 Test Submission Schedule

To allow for concurrent processing of both test and production data submissions, submission testing will begin the following schedule: All tests received by close of business on Thursday will be processed, reviewed and results returned no later than the following Tuesday. This schedule is effective immediately and will be followed until further notice.

THCIC Claims Match Criteria

THCIC uses the following data elements to create a key for matching xx7 (replacement), xx3 (intermediate interim), xx4 (final interim) and xx8 (void/cancel) claims. This key is used to group claims into encounters.

- THCIC ID Number
- PCN/PAN - Patient Control Number or Patient Account Number
- MRN – Medical Record Number
- Admission Date
- Admission Hour
- Type of Bill
- Statement Period From Date.

The use of these data elements maximizes the integrity of claim matching. However, it decreases the number of data elements that can be changed using the xx7 claim. To change any of the above data elements, the xx8 void claim must be used and then an original claim type can be submitted.

New CertView Software for 2004 Data

A new version of CertView is now available. The latest version, CertView v. 2.0, is to be used with first quarter 2004 certification data and beyond. This new version corrects the previous issues with PC incompatibilities and no longer requires any version of Microsoft Access. The installation file is now half the size of the previous, 15 megabytes instead of 32.

The software can be obtained at <http://www.thcichelp.com/Support.htm#Downloads>. You must uninstall any previous version of CertView prior to installing this version. Also, any existing comments must be re-typed after installing the new version.

There is an issue with the new release that is being addressed at this time. CertView Report C07, DRG Mortality Statistics by Practitioner, the “*Total*” values at the bottom of the two columns, Avg LOS and Avg Charges, are not correct. While close, the calculation was incorrectly computed by summing the column and dividing by the total cases. Thus the volume of cases per DRG is not factored in. This will be corrected before the release of the 4th Quarter 2004 Certification data. Notifications will be sent when the correction is available.

Warning Message 816

Also with this version, a new warning message 816 (for SSN discrepancies) has been implemented.

Deadline for corrections at time of certification extended.

In addition, to accommodate the delay with release of the corrected version, the deadline for **corrections at certification** is being moved to **April 30th**. The due date for certification letters and comments remains at **June 1st**.

Indicators of Inpatient Care in Texas Hospitals, 2003

The information to be included in the report is now available for hospital review and comment. Comments on the report will be accepted through May 30. The report is scheduled for release in June. Hospitals will be notified of the release date when it has been determined.

837 Technical Specifications Update

Release #14 of the 837 Technical Specifications is available on the THCIC website. The major change is the correction to the specifications for payer data that has been brought to our attention. The payer data requirements had inadvertently been changed for the subscriber NM1 segment and the payer NM1 segments.

Review of 2003 IQI Report Suspended

The Agency for Healthcare Research and Quality has announced that the software used to produce *Indicators for Inpatient Care in Texas Hospitals, 2003* is being revised to correct a problem found in the calculation of the risk-adjusted and expected rates. The review of the *Indicators* is therefore being suspended.

The revised software is expected by May 13 and the affected rates will be re-calculated. The corrected report is expected to be available to hospitals by the end of May for a 60-day review.

Review of 2003 IQI Report Resumes

The Agency for Healthcare Research and Quality (AHRQ) released updated files for the Inpatient Quality Indicators (IQIs) Version 2.1 on Thursday, May 19. The update was necessary to correct the calculation of the IQI expected and risk-adjusted rates. The indicators released to hospitals on April 1 overestimated the expected rate for individual hospitals based on the 2002 reference population (that is, overestimated the case-mix severity) and consequently underestimated the risk-adjusted rate. The revision corrects this problem.

The volume indicators are unchanged. The 23 mortality and utilization indicators have been revised and will be available for hospital review **beginning Wednesday, May 25**. The 60-day review period will **end on July 23**. Any comments submitted earlier must be re-submitted. The hospital identifier and password sent to all hospital primary contacts on March 25 are needed to access the IQI report. For help accessing the report contact Dee Shaw, 512-458-7111 x 3374. The report is scheduled for public release in August.

Your Feedback Requested for New PUDF Content and Format

At the last meeting of the Hospital Data Collection Workgroup on May 11, the format of the Public Use Data File (PUDF) for 2004 discharges was discussed. Year 2004 marks the beginning of data collection in the THCIC 837 format and the collection of up to 25 diagnosis codes and procedure codes and up to 10 E-codes. The availability of additional data will change the format in which the data are released.

THCIC proposed releasing a basic data file, following a file structure similar to the current PUDF, but including all of the additional diagnosis and procedure codes and E-codes, and a separate file to include detailed charges data. Because hospitals moved to submitting data in the THCIC 837 format at different times, it was suggested at the meeting that the basic PUDF for year 2004 discharges include up to 9 diagnosis codes, 6 procedure codes and 1 E-code, as if all the data had been collected in the UB-92 format. Any additional codes would be released in a separate file. It was also suggested that the basic PUDF, with the limited codes, be used by DSHS for any 2004 reports. Beginning with data for 2005 discharges, all diagnosis and procedure codes and E-codes would be included in the basic PUDF and used by DSHS for reporting.

These topics will be discussed further at a meeting of the Workgroup on June 22. THCIC is soliciting your comments on the content of the 2004 PUDF. The files for the first and second quarters should be ready for release in late July. Your comments on the number of codes that should be used by DSHS for 2004 reporting are also welcome. Please send any comments on these issues to Dee Roes at dee.roes@dshs.state.tx.us by June 20 so that your comments will be considered.

New Condition Code for Do Not Resuscitate

The National Uniform Billing committee authorized a condition code of “P1” for DNR - Do Not Resuscitate. The code became effective for data reporting on 2/23/05.

This code is for Public Health data reporting and is valid for submission to THCIC beginning with first quarter 2005 data. The code indicates that a “Do Not Resuscitate order” was recorded and noted in the patient’s medical record within 24 hours of admission to the hospital.

CCS Improves Claim Submissions Notification Process

Data submissions are now pulled automatically during business hours. Submitters can expect that a receipt response will be sent within **minutes** of disconnecting from the system.

Preprocessor reports are now triggered by the completion of audits, instead of being triggered by a manual notification process.

Indicators of Inpatient Care in Texas Hospitals, 2003 to be Released

THCIC will release the annual report on Texas hospitals on September 13, 2005. The report is based on methodology developed by the Agency for Healthcare Research and Quality (AHRQ). The indicators include three distinct types of measures:

Volume measures examine the volume of inpatient procedures for which a link has been demonstrated between the number of procedures performed and outcomes.

Mortality measures examine outcomes following procedures and for common medical conditions.

Utilization measures examine procedures for which questions have been raised about appropriate use.

The report includes a searchable database of the 2003 hospital performance. The Department of State Health Services will issue a press release on the availability of the report.

Review of Mortality-Indicators of Inpatient Care in Texas Hospitals, 2003

A problem with the 2003 Indicators of Inpatient Care in Texas Hospitals was recently discovered in that patients transferred to rehabilitation hospitals and some long-term care facilities were excluded from the initial calculation released September 13. These patients account only for about 2.5% of the total inpatient discharges in 2003. The exclusion adversely affected only the mortality indicators. Revised calculations for the mortality indicators will be sent to hospitals for a 60-day required review and comment process. These indicators will be released at the conclusion of the review.

THCIC expects the review process to begin as early as the first of next week and will send out another numbered letter to the hospital primary contact announcing that date. Hospitals are to use the passwords and identifier issued for the initial review of the 2003 IQI. Questions about the password/identifier should be directed to Dee Roes by e-mail at dee.roes@dshs.state.tx.us.

Measures unaffected by the omission of these patients are Volume and Utilization. These measures are already available to the public.

Review of Revised *Indicators of Inpatient Care in Texas Hospitals, 2003*

Patients transferred to rehabilitation hospitals and some long-term care facilities were excluded from the initial *Indicators of Inpatient Care in Texas Hospitals* for 2003 reviewed by hospitals in the summer. These patients account for about 2.5% of the total inpatient discharges in 2003, but the exclusion adversely affected the mortality indicators. Revised calculations for the mortality indicators will be available for the required review and comment process beginning tomorrow, **October 5, 2005, ending December 3**. Volume and Utilization indicators are unaffected by the omission of these patients and are available on the THCIC website.

Comments submitted during this review will be appended to the comments previously submitted. Hospitals are in order by MSA and by the same hospital number used for the review of the indicators in the summer. 
Claim Counts Per Quarter Report Via Secured Server

FER REPORT CHANGES

The Frequency of Error (FER) report has several new changes that are being implemented to assist you in tracking your data submissions.

First there are different report titles that identify whether the file submission was an original 837 data submission (“837 EDITS - NEW SUBMISSION DATA” or “837 REJECTED NEW SUBMISSION DATA”) or a DCS corrections submission (“837 RE-EDITS - CORRECTIONS DATA”). The titles will be listed in the top left hand corner of the text documents.

Second there is a breakdown of the number of data claims received. How many were rejected, how many did not match, previous data claims and how many data claims were processed by CCS).

Third, there is a note added to the bottom of the “837 REJECTED NEW SUBMISSION DATA” FER report telling you to look at the “Rejected Claims Report”.
