SUBJECT: Mead Johnson Product Changes 2016

Ready-to-Use 32 ounce Cans Discontinued:

Several Mead Johnson ready-to-use 32 ounce formula cans have been discontinued. The last shipping date for these products is 2/29/16. An attached handout summarizes the ready-to-use formula sizes and codes that are either available or discontinued.

Formula Packaging and Code Changes:

The following formulas will be discontinued and converted to an equivalent 8 ounce – 6 pack formula code

Effective April 1, 2016:

- (442) ENFACARE RTU 32OZ Converted to (591) ENFACARE RTU 8OZ-6PK (48OZ)
- (401) ENFAMIL AR RTU 32OZ Converted to (587) ENFAMIL AR RTU 8OZ-6PK (48OZ)
- (375) PROSOBEE RTU 32OZ Converted to (586) PROSOBEE RTU 8OZ-6PK (48OZ)

Effective immediately:

Do not issue formula codes 442, 401 or 375 due to limited availability of the 32 oz cans. After April 1, 2016, if these codes are entered for issuance, the converted formulas will be issued in their place.

Bottle and 6 Pack Formula Codes:

The following formulas are available in **both 32 oz plastic bottles and 8oz – 6 packs**. Either can be issued depending on availability in your local area. Formula codes are provided below:

32 OZ BOTTLE

- (487) ENFAMIL INFANT RTU 32OZ
- (500) GENTLEASE RTU 32OZ
- (024) NUTRAMIGEN RTU 32OZ

8 OZ – 6 PACK

- (588) ENFAMIL INF RTU 8OZ-6PK (48OZ)
- (589) GENTLEASE RTU 8OZ-6PK (48OZ)
- (590) NUTRAMIGEN RTU 8OZ-6PK (48OZ)

Mead Johnson Formula Ready-to-Use Facts

- Use the tables provided above to assist in making issuance decisions. Staff may need to check local availability before issuing a Mead Johnson ready-to-use formula code.
- The following formulas can be issued in **either** the 32 oz size or the 8 oz – 6 pk
 - **Enfamil Infant**
 - **Gentlease**
 - **Nutramigen**
- Please note that 8 oz-6 pk codes are issued and purchased by the 6 pack, not by the 8 oz container. If the shopping list shows a quantity of 17, that means 17 – 6 packs. (Similar to Enfaport which is issued and purchased by the 6 oz – 6 pack).
