Figure 1. Texas Counties Reporting Arbovirus Activity, Week 35

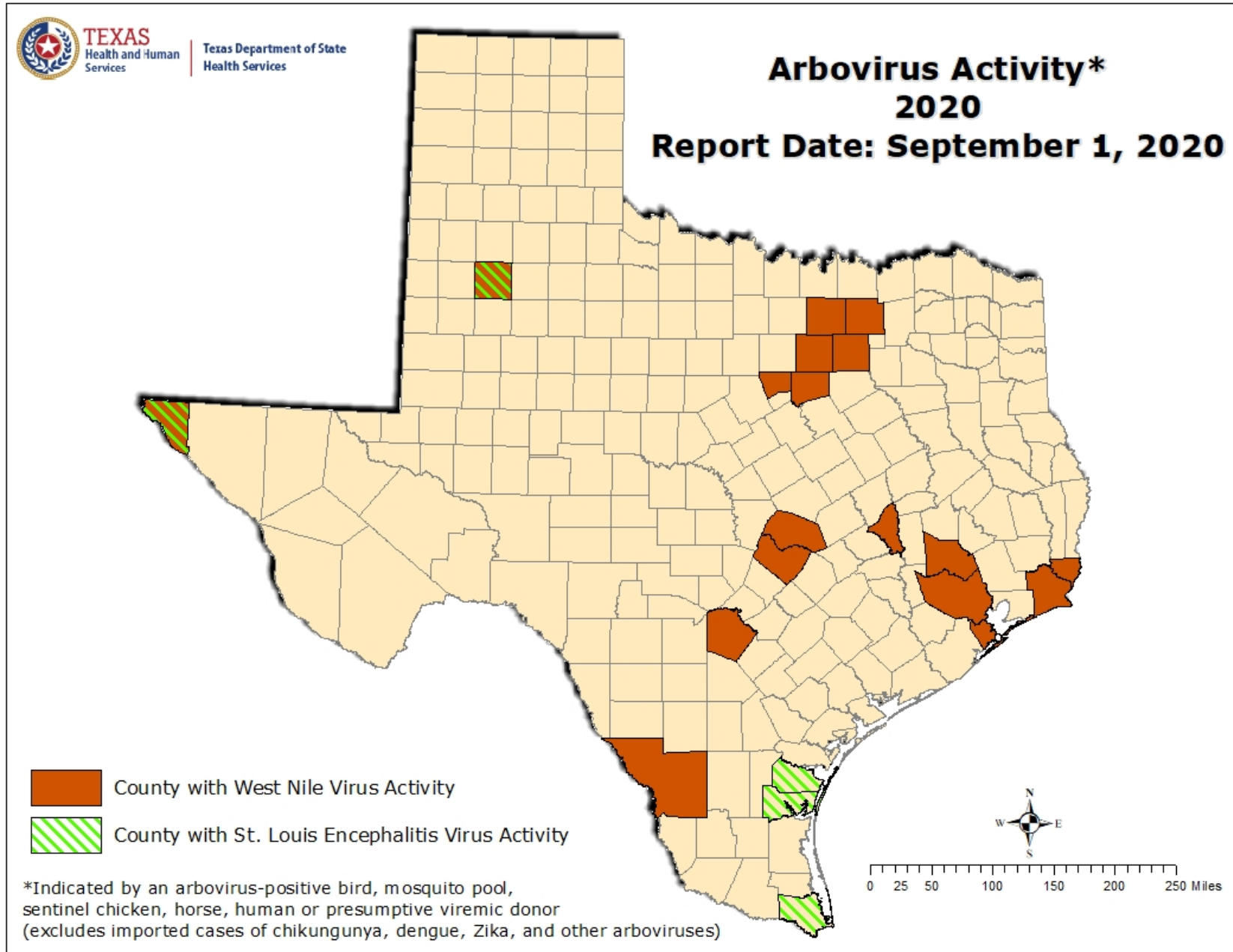


Figure 2. WNV-Positive Mosquito Pools Reported in Texas, by MMWR Week of Collection, 2018-2020, Week 35
