## Something Old and Something New: Blending the Landscape of EMS Education in Texas

Education has evolved and the way we teach adults in EMS education must combine the old with the new to give EMS educators and our students the tools to become better providers of emergency medicine. Here are some techniques that can be employed to increase instructional performance and combine the tried and true with today's technology and tactics.

• **Visualization**

Bring dull academic concepts to life with visual and practical learning experiences, aiding your students to understand how their training or education applies to better patient care. (Sarah, 2018)

• **Cooperative Learning**

Encourage students of mixed abilities to work together by promoting small group or whole class activities. (Sarah, 2018)

• **Inquiry Based Instruction**

Create thought-provoking questions and scenarios which inspire critical thinking in your students to think for themselves and become more independent learners. (Sarah, 2018)

• **Introducing Technology in the Classroom**

Incorporating technology into your teaching is a great way to actively engage your students, especially as digital media surrounds millennial students (Sarah, 2018)

• **Instructor Professional Development**

Having instructors engaging in regular professional development programs outside of EMS is a great way to enhance teaching and learning in your classroom.

As “baby boomers” age we are seeing a shortage of workers who want to provide emergency medical services partly due to other occupations that are available that might pay more, be more glamorous, and are perceived as less dangerous. For those who want to enter the EMS field as providers, we must look at some specific process that faculty/instructors can employ to increase student success throughout the EMS program.

- **Adult learning-** Adult learners have unique needs compared to other students. The adult learner wants to be able to complete a volume of education and be able to take what they have just learned and put it to use in their daily practice. (Karell, 2018)
- **Flipping the classroom-** The standard has been the typical classroom with an educator lecturing to students in the classroom. This will usually include power point slides, charts, and anatomical aids. Flipping the class room can have the students study outside of the classroom and coming to class asking questions over the assigned material instead of listening to a lecture. Scenarios can also be added over the material in class to reinforce critical areas of the topic(s).
- **Use of Blogs-** A blog is usually a website maintained by a person or a group of people to share thought and ideas. This allows people to post views and information via a chat room and provide threads on a variety of topics that are shared and give them the opportunity to learn from each other. The instructor can assign topics to be discussed and steer the discussion without being in a classroom.
- **Videos-** Some concepts, especially skills can be demonstrated with the introduction of videos to show the chronology, techniques, and evaluation for the process that might be more difficult in the typical classroom setting.
- **Peer Review-** Many seasoned educators may call this “see one, do one, teach one.” It is a way to allow students to teach each other. The students should receive a mastery demonstration from the instructor and have the students demonstrate it back in group setting with students reviewing and correcting incorrect performance.
- **Testing-** Pencil and Paper Testing. Most of us are most familiar with pencil and paper testing. It is probably the easiest to develop and grade and is the current method most utilized. Computer Based Testing is very linear; meaning each student on the computer taking the exam receives the same test question as everyone else.
- **Computer Adaptive Testing-** CAT is very dynamic as the computer adapts the test questions to each individual candidate based upon their ability to answer the questions. This allows the instructor to test the material in a more precise manner and examine the student’s ability to use critical thinking skills over the subject matter.

Adapting to our students requires faculty/instructors to face the challenge of reaching adult learners at different levels of ability to gather, learn, and perform the difficulties of EMS education. We must use a combination of instructional strategies to address the different learning styles of our students. As we make our techniques of presentation more diverse we have a greater chance of seeing more successful learners.

## Texas hospitals designated for Neonatal Levels of Care

The Office of EMS/Trauma Systems is pleased to announce that 233 hospitals have successfully met the standards established in Texas to receive initial designation for neonatal levels of care. [Texas Administrative Code, Title 25, Chapter 133, Subchapter J](#), required all Texas licensed hospitals to be designated prior to September 1, 2018, in order to be eligible for Medicaid reimbursement.

There are four levels of care for Neonatal designation.

**Level IV (Advanced Intensive Care Unit)** as the highest level and provides comprehensive care to the most complex and critically ill infants.

**Level III (Neonatal Intensive Care Unit)** provides care to infants of all gestational ages, with mild to critical illnesses or requiring sustained life support.

**Level II (Special Care Nursery)** provides care to infants with immaturity or problems that are expected to resolve rapidly.

**Level I (Well Nursery)** provides basic care to well infants.

The designation levels and number of hospitals designated at each level are as follows:

Level IV:	20
Level III:	57
Level II:	75
Level I:	81

## Maternal Designation Begins for Hospitals in Texas

[Texas Administrative Code, Title 25, Chapter 133, Subchapter K](#), maternal designation rules became effective March 1, 2018. The second phase of the implementation of House Bill 15 included the development of maternal designation rules recognizing four levels of maternal care and hospitals are required to be designated by September 1, 2020, to be eligible for Medicaid reimbursement for maternal services.

On-site surveys began in July 2018 and have been conducted in facilities seeking level IV designation. Survey organizations are currently scheduling for facilities seeking level II, III or IV designation.

# Where to Find It

When you are the one that responds to calls for help, it's easy to ignore triggers that first responders face due to crisis and stress. Symptoms can include, erratic sleep, sleep difficulty or dysfunction, anxiety, depression, substance use and abuse, PTSD, suicidal ideation, and suicide.

Some strategies to alleviate these symptoms may include:

Effective and thorough on-the-job training programs;

- Physical fitness;
- Strong social, organizational, and personal support systems;
- Self-care partnered with self-awareness,
- A commitment to help one another, and
- Professional help when needed.

While these may help, the risk will not be eliminated. There are a variety of ways to access free and confidential assistance for those who experience stress injuries or other behavioral health issues.

## AED REPORTING

We've had recent questions on whether AED acquisition and usage need to be reported directly to the Office of EMS/Trauma Systems ; no, this is not required. Per the Texas Administrative Code Rule §157.41 Automated External Defibrillators for Public Access Defibrillation states that the following notifications are required:

- (1) A person or entity that acquires an AED shall immediately notify all local emergency medical service providers of the existence, physical location and type of device.
- (2) A person or entity that uses an AED shall notify the local emergency medical service (911) provider after the AED is used.
