**S**imply put, Texas has a trauma system because of Kathy Perkins. She would be the first to deflect any praise and give the credit to those who believed in her vision and worked to create the system, but Perkins spent years making endless phone calls to hospitals and EMS providers asking them to participate in what was a voluntary system to improve trauma care. She relied on those volunteers and encouraged them to believe that wide ranging and unorganized resources that included 1,000 emergency medical services providers and 300 hospitals could become the fully implemented statewide trauma system.

**On November 30** Perkins retired from her position as DSHS Assistant Commissioner for Regulatory Services. She began her career in 1989 as a statistical clerk in the Bureau of Emergency Management. As Assistant Commissioner she oversaw regulation of everything from alligator meat to youth camps, but she always had EMS/Trauma System within her purview, and, as she likes to say, in her heart. The EMS/Trauma System has grown over the years and now includes a

strong system of Regional Advisory Councils devoted to emergency care and disaster response, a functioning trauma registry, 286 designated trauma facilities, 148 designated stroke facilities and neonatal along with maternal designation coming soon.

As an ex-Army nurse, Kathy says one of her proudest achievements was making sure military hospitals were included in the trauma system, which put Texas at the forefront of research for improving care for soldiers on the battlefield in Iraq and Afghanistan. After decades in state government, she's taking some time to travel and spend with family before she decides what comes next. But she's sure of one thing; she is determined to continue making a difference in the lives of Texans. On November 22, the Governor's EMS and Trauma Advisory Council (GETAC) presented Kathy with a lifetime achievement award for providing vision and leadership to the Texas EMS/Trauma System.

## REPORTING TO LEGISLATURE

On December 1 of each even-numbered year, the department shall electronically submit a report to the lieutenant governor, the speaker of the house of representatives, and the standing committees of the house and senate with jurisdiction over the department on the effect of the changes made within the State EMS system. The following questions must be answered in this report;

- (1) the total number of applications for emergency medical services provider licenses submitted to the department and the number of applications for which licenses were issued or licenses were denied by the department;
- (2) the number of emergency medical services provider licenses that were suspended or revoked by the department for violations of those sections and a description of the types of violations that led to the license suspension or revocation;
- (3) the number of occurrences and types of fraud committed by licensed emergency medical services providers related to those sections;
- (4) the number of complaints made against licensed emergency medical services providers for violations of those sections and a description of the types of complaints; and
- (5) the status of any coordination efforts of the department and the Texas Medical Board related to those sections.

### Don't get fired for Facebook: 10 ways to use social media safely

How to make sure your online activities do not interfere with your job as a paramedic or EMT at your agency

We've seen several cases in recent months where EMS providers have gotten in hot water and even lost their jobs for posting what their employer believed were inappropriate images, videos, or comments. For instance, take a look at SC firefighter-paramedic fired over Facebook video post or NYC EMS lieutenant may lose job over Facebook post, prank.

Internet access to global electronic information resources and to social networking media has revolutionized information sharing. These networking capabilities are changing the way we work and communicate with each other.

But with this new societal free flow of "information sharing" comes legitimate patient privacy and business concerns for the EMS employer. EMS agencies — both public and private alike — have a legitimate business interest to ensure that social networking is used in a way that does not violate patient confidentiality, harm the organization's reputation and business interests, or interfere with the work of others.

How can you make sure that your online activities do not interfere with your job or work activities at your EMS agency? The main thing is to always think about how others in your agency or the public would perceive your comment before you post it.

In other words, think before you hit the "enter" key. One of the problems with "reacting" to an event or someone else's post is that your own reaction will likely reflect your emotions at the time. Ideally, you should craft a thoughtful response after some reflection. "Reacting" rather than "responding" may cause you to post something you may regret later.



## Name Change: EMT-I to AEMT

Senate Bill 219, passed during the regular session of the 84th Legislature, requires changing the name of Emergency Medical Technician-Intermediate (EMT-I) to Advanced Emergency Medical Technician (AEMT). The change will take effect January 2017 and the process will take 4 years to complete. In Texas an EMT-I and AEMT are recognized as the same level of certification. When a current EMT-I renews their certification the certification level will be changed to AEMT, no further action is needed. **Please note** that there may be additional requirements to maintain and be recognized as a National Registry AEMT, for that information please go to <https://www.nremt.org/rwd/public>
