Members of the public may also use the Microsoft Teams Live Event Q&A section to submit a request to provide public comment. The request must contain your

name and the organization you are representing, as well as your direct phone number if you are speaking as a private citizen.

Public comment is limited to 3 minutes. Speakers must state their name, affiliation, and whom they are speaking on behalf of. Public members who are using handouts are asked to provide an electronic copy in accessible pdf format that will be distributed by DSHS staff to Council members, State staff and for public distribution. Handouts are limited to two pages (paper size: 8.5" by 11", one side only).
