Perinatal Hepatitis B Prevention Program (PHBPP) Annual Report

The Perinatal Hepatitis B Prevention Program (PHBPP) is required to report the outcomes of infants born to Hepatitis B infected mothers in the CDC's annual report. The annual report is due each year in March.

CDC Vaccine Storage and Handling Toolkit

The Centers for Disease Control and Prevention (CDC) has released a new Vaccine Storage and Handling Toolkit to use as a guide for healthcare professionals to promote the safeguarding of vaccines. This toolkit provides recommendations for:

- Managing vaccine inventory and transport
- · Storing and preparing vaccine
- · Monitoring vaccine temperature
- · Using and maintaining storage unit and temperature monitoring equipment
- Preparing for emergency storage, handling, and transport situations
- Developing standard operating procedures for routine and emergency vaccine management and training staff

The CDC Vaccine Storage and Handling Toolkit is a helpful guide to ensure safe vaccine storage and handling, however requirements for the Texas Vaccines for Children (TVFC) Program may vary. For the TVFC and ASN Programs vaccine storage and handling requirements please refer to the <u>Texas</u> <u>Vaccines for Children and Adult Safety Net Provider Manual</u>.
