SUBJECT: Texas Vaccines for Children Program : Influenza Order for 2010

*****Important*****

Please read this entire memo prior to placing 2010-2011 influenza orders

Texas Vaccines for Children (TVFC) Program providers may now place orders for the **2010-11 Influenza Season**. Providers will again use an online process to place orders. The deadline for placing an order is March 17, 2010. Please keep in mind that the order you place now is your actual influenza order that will be delivered October-December 2010.

Providers may request preferred influenza product brands and formulations, and these requests will be honored to the extent possible. Choice is limited to products and funding allocated to TVFC by the Centers for Disease Control and Prevention. Orders may be filled in their entirety or in partial shipments as vaccines become available next fall.

2010-2011 Electronic Influenza Order Process:

Prior to March 17, 2010:

1. Choose your region or city from the drop down list. Note: Your region is the first two numbers of your TVFC PIN (039876 would be in region 3) except for City of Houston which is listed under 25.
2. When the second drop down list appears, select your clinic and PIN. If you do not see your PIN in the list, please enter your 6-digit TVFC PIN in the blank provided, using the leading 0 (zero) if applicable.
3. Enter contact information as indicated.
4. Influenza vaccines are listed by applicable age categories. Enter the number of doses of each influenza product you would like to order (this order should be based on reliable information such as client numbers, this year's doses administered, next year's influenza clinic plans, etc.).
5. Enter doses in increments of 10 using only numbers, for example enter 10, not ten.
6. The light bulb symbol next to a vaccine type will provide additional information relating to that specific vaccine.

7. Enter the full name of the person completing the form (must be a person listed on the clinic's enrollment form, but does not have to be the actual enrolled signing provider).
8. Read the authorizing section and click on the "I agree" buttons if you agree.
9. When you are satisfied with the order, and prior to submitting, print a copy of the order for your records by right clicking on the mouse and hitting "print".
10. To submit your order request for the 2010-11 influenza season, click on the "Submit Order Form" button at the bottom of the order.

Note: If you need to change your order after it has been submitted, you must start over and enter a completely new order. The most recent order for any designated PIN will be considered the final order.

2010-2011 Electronic Influenza Order Deadline

The deadline to submit an order is March 17, 2010. Orders received later than this date may not be filled with product choice or doses requested. Online submission of influenza orders is preferred, however, if a provider site does not have access to the web to place the order, a physical order form may be used. Please contact the local health department or health service region where you submit your regular TVFC orders to obtain a physical form.

2010-2011 Influenza Vaccine Information Statement (VIS)

The 2010-11 VISs should become available for order in late summer or early fall of 2010. By federal law, an appropriate VIS must be given to all patients, or their parent or legal representative when receiving an influenza vaccine. VISs will not be included with influenza vaccines. VISs must be ordered by providers early enough to ensure they are available prior to receiving influenza vaccine.

2010-2011 TVFC-Supplied Influenza Vaccine Recommendations

TVFC-supplied influenza vaccine is reserved for children 6 months to 18 years of age as follows:

- *TVFC Children Eligible for Trivalent inactivated influenza vaccine (TIV):*
 - All children aged 6 months through 18 years.
- *TVFC Children Eligible for Live, Attenuated Influenza Vaccine (LAIV):*
 - All healthy children and adolescents (those who do not have an underlying medical condition that predisposes them to flu complications) aged 2 years through 18 years.

Vaccination efforts should continue throughout the season, because the duration of the influenza season varies, and influenza might not appear in certain communities until February or March.
