



Asbestos, Lead, & Mold State Examination Calendar September 1, 2015 – August 31, 2016

Persons who wish to sit for a state examination must submit a completed examination registration form, application fee, and all required documentation. Applications should be mailed at least four weeks prior to the requested examination date. An examination confirmation letter will be emailed, faxed or mailed after all items have been received and the application is approved. A confirmation letter and valid photo ID are required for admittance into an exam site. Examination walk-ins are not allowed under any circumstances. Exam locations and dates are subject to change. Should this occur, all examinees will be notified as soon as possible.
