


Texas Outbreaks PHEP BP-11 8/14/11 - 8/4/12







Outbreaks Reported

- 54 local and regional health jurisdictions (8 regional and 46 local single or multi-county jurisdictions
- 49 (91%) submitted outbreak-tracking forms for PHEP BP-11 (8/4/11-8/14/12)
- 268 outbreaks reported by local and regional disease surveillance staff in 31 jurisdictions
- 262 (98%) were investigated






Salmonella Clusters

- 85 PFGE Salmonella clusters were reported from 8/4/11 through 8/14/12
- 75 were multi-state clusters
- 10 were Texas only
- 46 of the clusters were reported as 84 outbreak investigations by 19 jurisdictions
- Some jurisdictions did not include PFGE cluster investigations in their tracking reports
- 12 Salmonella outbreaks were not initiated by PFGE typing




Enteric Outbreaks and Cluster Investigations by Month Reported






Respiratory Outbreaks by Month Reported








Varicella Outbreaks by Month Reported

Summary Reports

- > 268 Outbreaks reported by LHD/RHD staff
 - >262 (98%) Investigated
 - ≥160 (61%) Summary reports written
 - ➤Of 102 without reports, 69 (68%) were Salmonella cluster investigations

➤ 132 (83%) – Minimum report elements included by self report

Ability to understand

- What, When, Where Who, Why
- Public health response
- Outcome
- Opportunities for improvement

Forms

Collect details

Narrative

- Add details not covered in forms
- o Summarize
- o Reflect



Examples

- Narrative
- Form
- NORS report and addendum



Tips

- Make sure details are visible if NORS printout is used
- Don't include individual case reports or questionnaires, materials provided as resources, etc. Summarize key information.
- Make sure details add up
- Investigation summary notes are useful if brief
- Summary reports not required for investigation of a multi-regional PFGE identified isolate
