Antimicrobial Use and Resistance Updates

Antimicrobial Assessment Tool



Antimicrobial resistance (AR) occurs when a germ develops the ability to defeat medicines designed to kill them. According to CDC's [AR Threats Report](#), AR sickens more than 2.8 million people and kills at least 35,000 people in the United States. The Healthcare Safety Unit supports healthcare facilities to combat AR by providing non-regulatory assessments of proper antibiotic use and improving prescribing practices.

These free and voluntary assessments:

- Provide feedback to improve patient outcomes
- Reduce infection treatment costs
- Strengthen how antibiotics are prescribed and used in healthcare facilities
- Improve CDC Core Elements for improving antibiotic use

Preventable Adverse Events

Preventable Adverse Events (PAEs) cause unintended harm by an act of commission or omission (not the underlying disease or condition), such as medication errors or foreign objects retained after surgery. Chapter 98, Texas Health and Safety Code requires general hospitals and ambulatory surgery centers to report PAEs to DSHS. PAEs are reported when they occur or at least quarterly within 60 days of the end of the quarter. The next reporting deadline is August 31, 2025, for events occurring during April-June 2025.

Project Firstline



[Measles](#) is a highly contagious infectious disease which can lead to severe illness and even death; early identification and immediate action are crucial. Centers for Disease Control and Prevention's (CDC's) Project Firstline created [Infection Control Micro-Learn: Measles](#), an infection control training tool. The measles micro-learn provides an adaptable discussion guide to facilitate conversations on-the-job where groups of healthcare workers meet (e.g., pre-shift huddles, team meetings).

This measles micro-learn provides a clear disease overview, outlines key symptoms, airborne transmission risks, and the importance of the Measles, Mumps, and Rubella vaccine for healthcare workers. It also offers step-by-step guidance for suspected measles cases and actions you can take to prevent the spread (e.g., isolation protocols, proper personal protective equipment, and the importance of communication with infection prevention teams and public health authorities). This resource serves as a valuable tool to recognize and prevent the spread of measles in healthcare settings.

Workplace Violence Prevention

Workplace violence occurs more often in healthcare settings than in any other occupation but is often underreported. Workplace violence is any act or threat of violence including verbal abuse, physical assault, bullying and harassment. The events can have serious physical and mental effects on healthcare staff. [Chapter 331 of the Texas Health and Safety Code](#) requires healthcare facilities to establish and enforce a workplace violence prevention program that includes violence prevention training, confidential reporting, preventing retaliation and offering post-incident services. The Occupational Safety and Health Administration and The Joint Commission provide resources and training for workplace violence prevention.

Feeling Overwhelmed?



Life is filled with many changes which can lead to stress or anxiety. The National Institute of Mental Health (NIMH) released a factsheet, "[I'm so stressed out!](#)" This resource helps readers learn and recognize the symptoms and differences between stress and anxiety, management strategies, and when more help is needed.

NIMH defines stress as a response to an external event that usually goes away once the situation is resolved, while anxiety is an internal reaction to stress that is constant without any clear threat. Symptoms include excess worry, unease, headaches, or trouble sleeping. The fact sheet provides coping techniques such as journaling, exercise, and breathing techniques. Learn the differences and how to manage them to help reduce stress, anxiety, and improve your daily life.
