




COVID-19 Vaccine Texas Overall Summary




1-dose includes one-dose Pfizer, Moderna, and J&J COVID-19 Vaccines

— First Doses 7-day Rolling Average


— Second Doses 7-day Rolling Average








COVID-19 Vaccine Fully Vaccinated 12+

Texas Total Population, 12+




People vaccinated as of 6/25/21, 12+









Texas Total Population, 65+




People Vaccinated as of 6/25/21, 65+







Texas Total Population, 12-17





People Vaccinated as of 6/25/21, 12-17

Texas Ordering Cadence

- Starting the week of May 24th (week 22), providers have been able to place orders of doses as small as one vial (5, 6, or 10 doses, depending on the manufacturer) on a weekly basis.
 - DSHS has been working with partners to facilitate delivery of these very small orders.
- Per the CDC guidance, effective June 24th, no longer limited in the amount of vaccine available for ordering.
 - Pfizer (450 doses) and Moderna (100/140 doses) are the only available vaccines at this time.
 - Continue to work with the CDC on transition to ‘normal’ ordering process.
- DSHS continues to consult with the Expertise Vaccine Allocation Panel on vaccine distribution.
 - Meeting with EVAP approximately once a month.


