Figure 1. Texas Counties Reporting Arbovirus Activity, Week 41



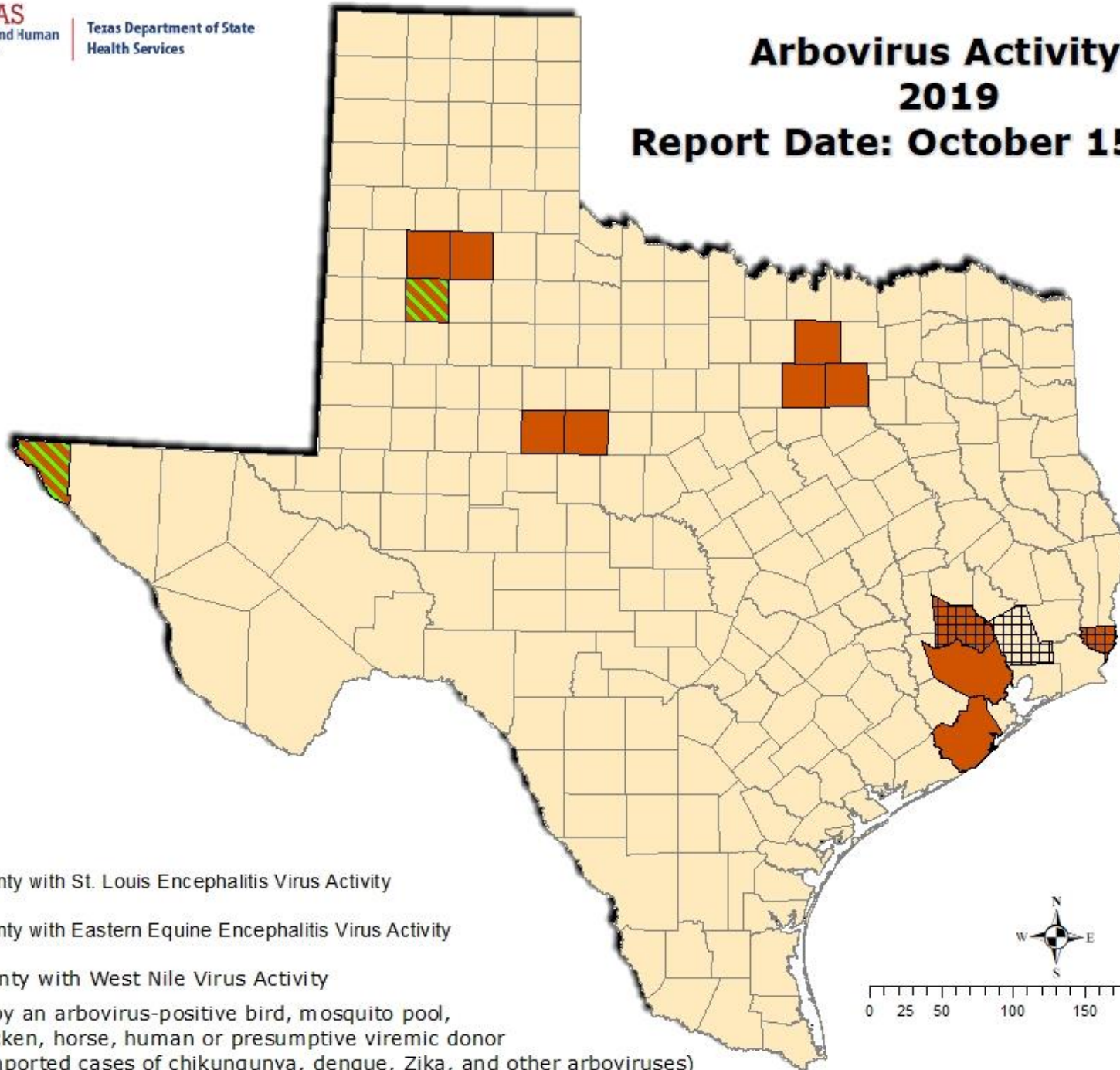

Figure 2. WNV-Positive Mosquito Pools Reported in Texas, by MMWR Week of collection, 2017-2019

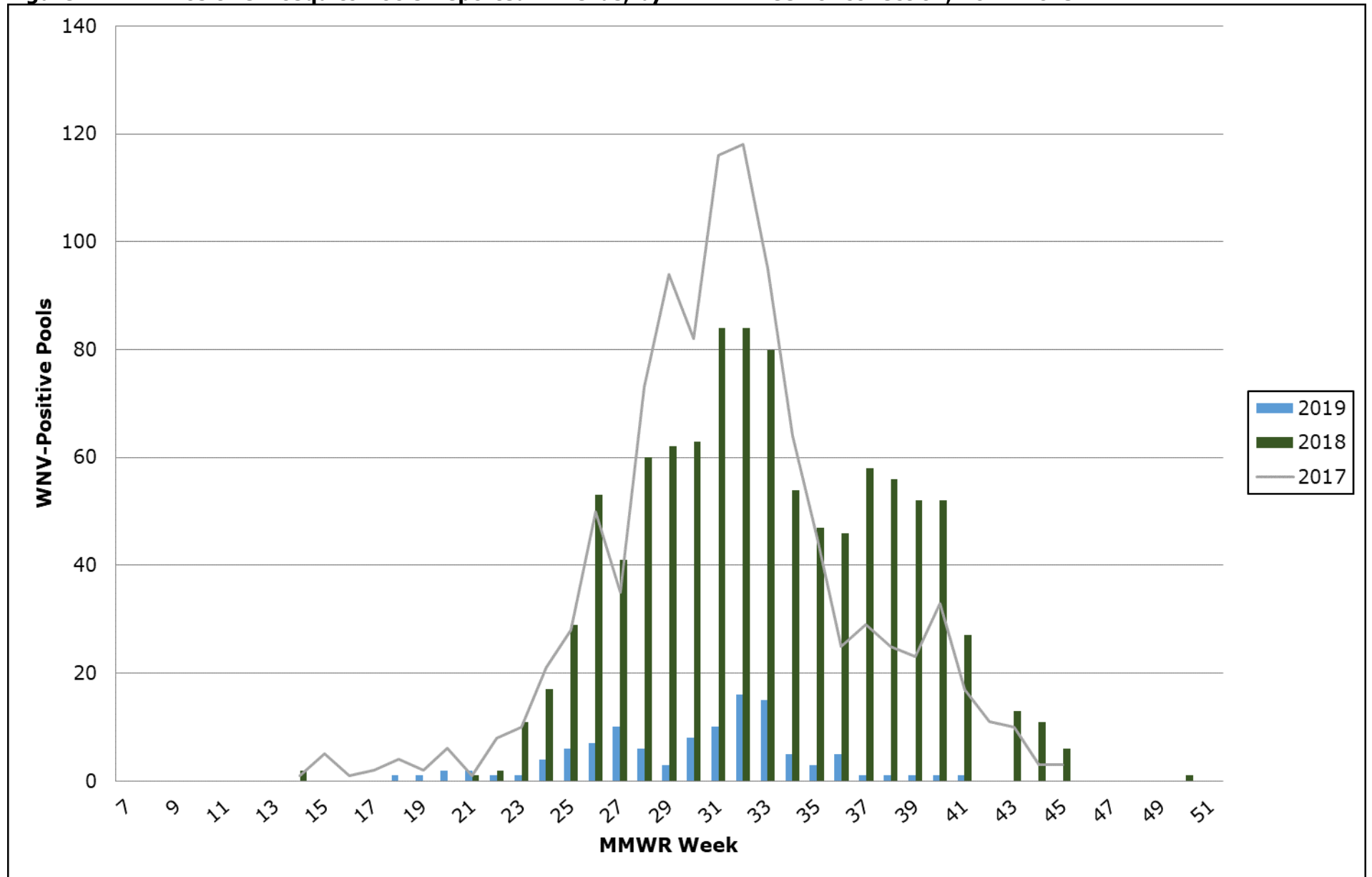


Figure 3. Human Cases of West Nile Virus Reported in Texas, by MMWR Week of Onset, 2017-2019
