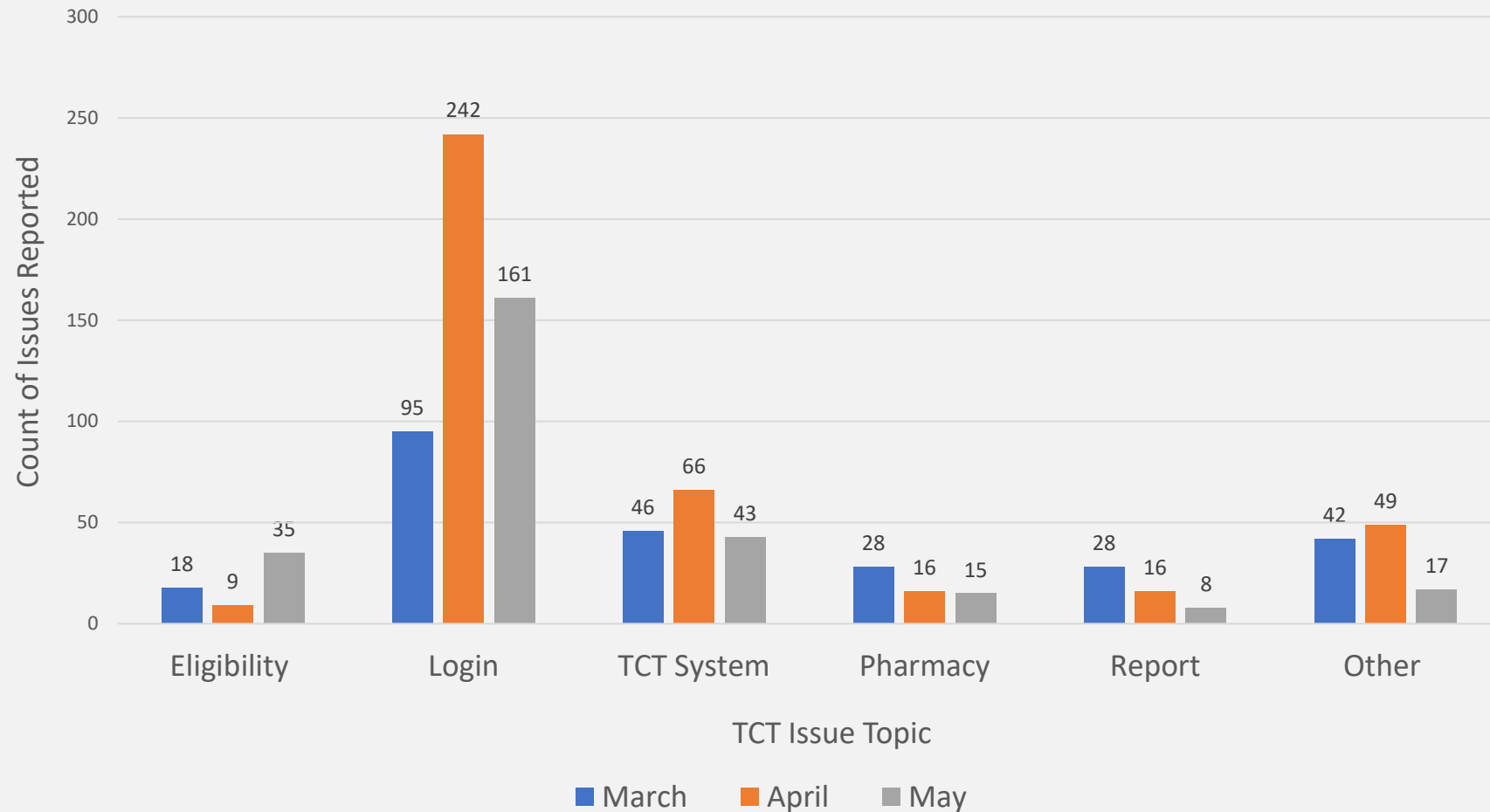

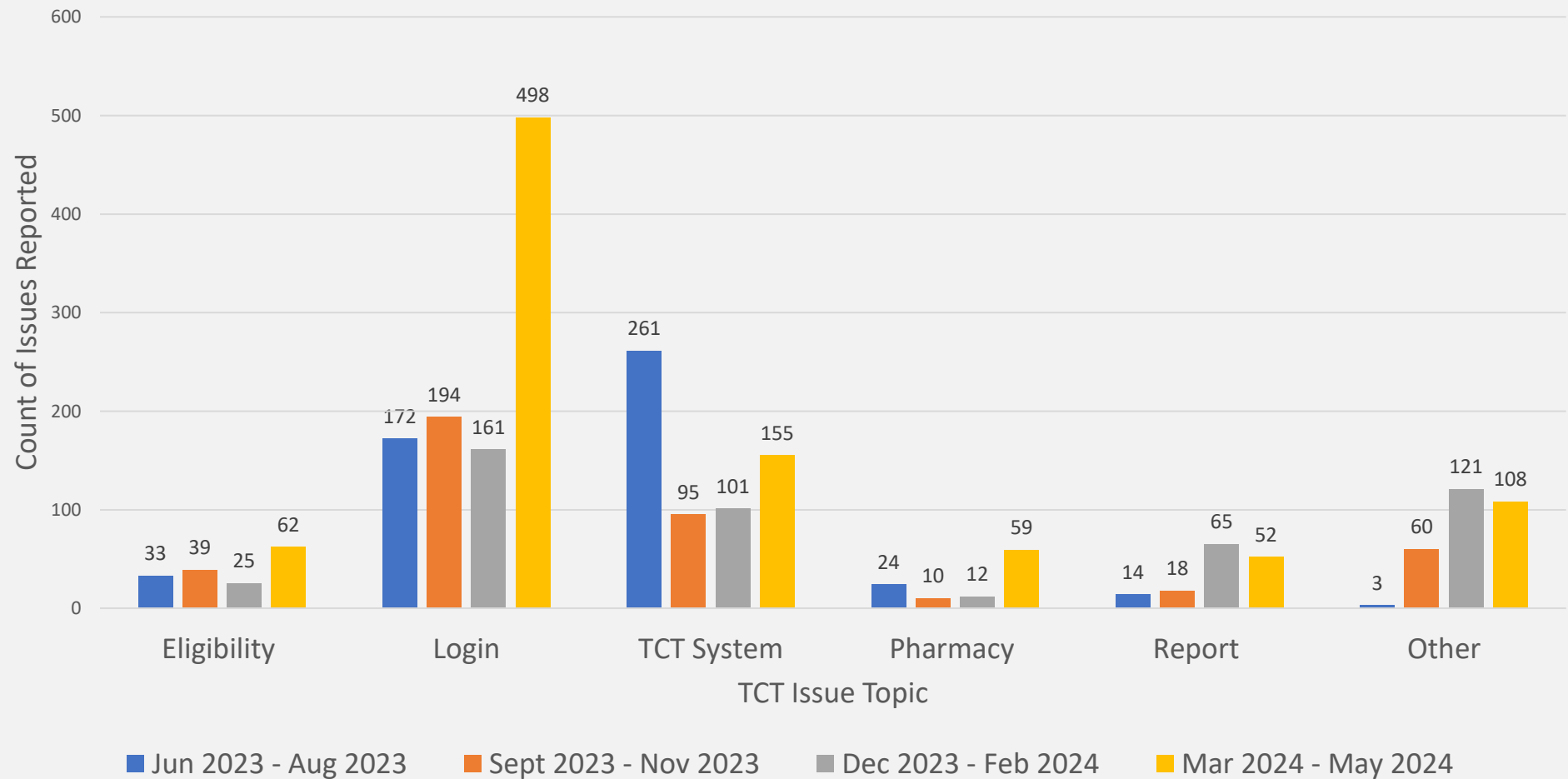

June 1, 2023 – May 31, 2024



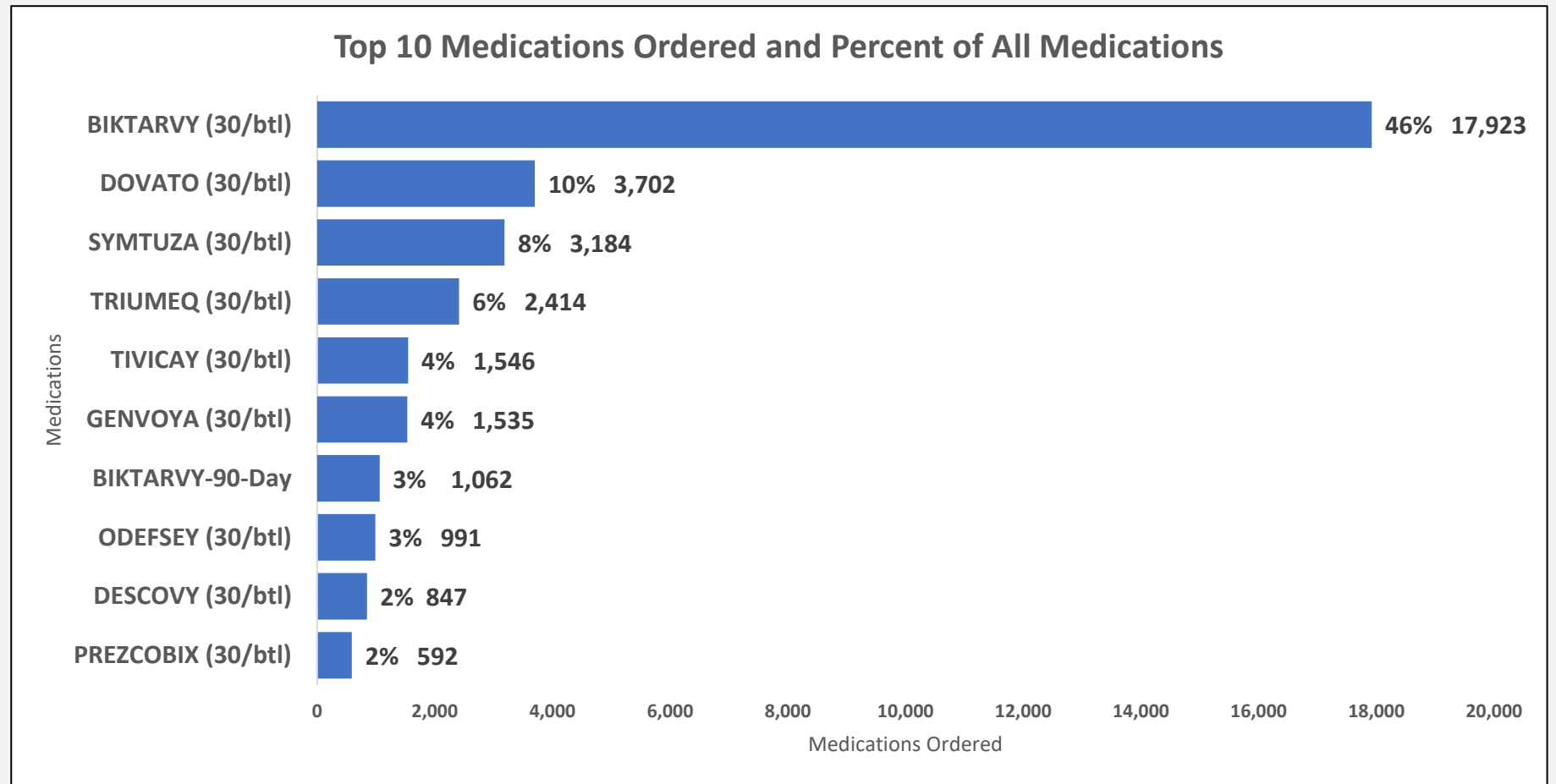

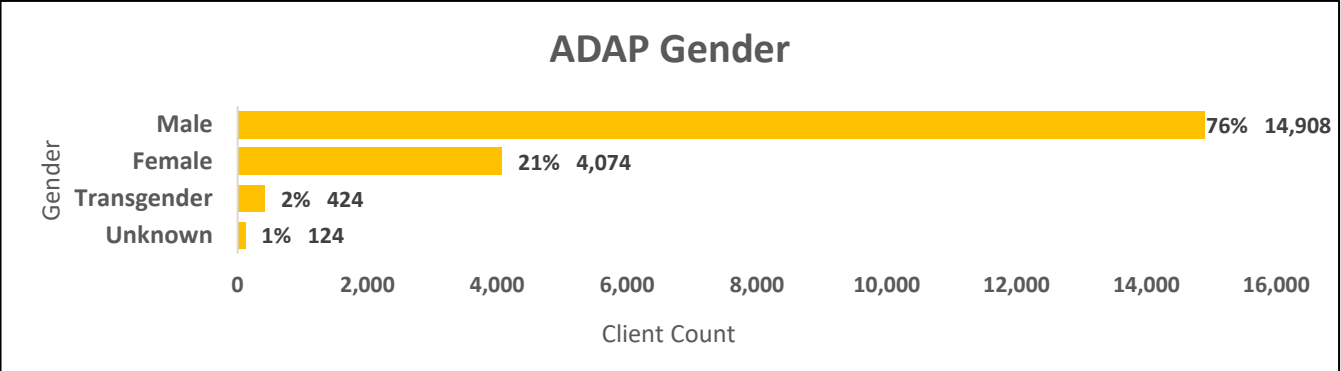
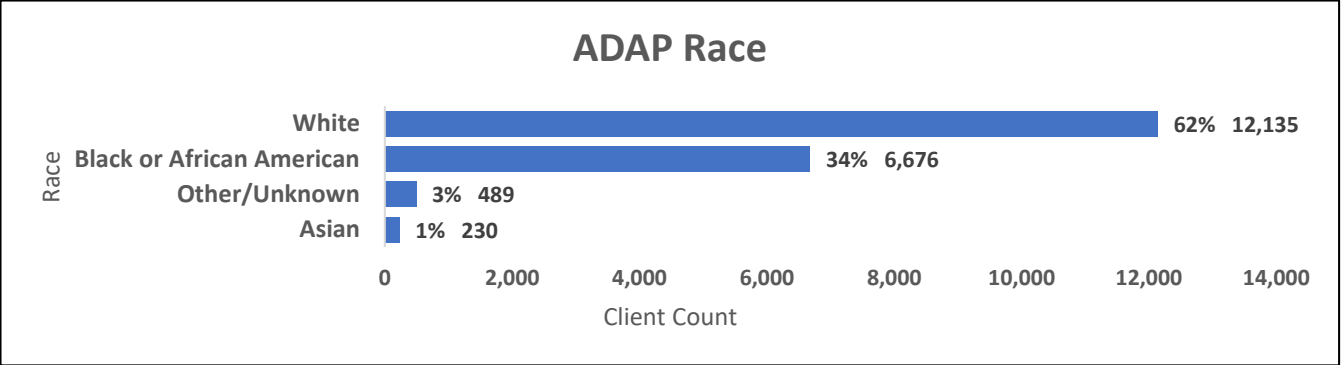
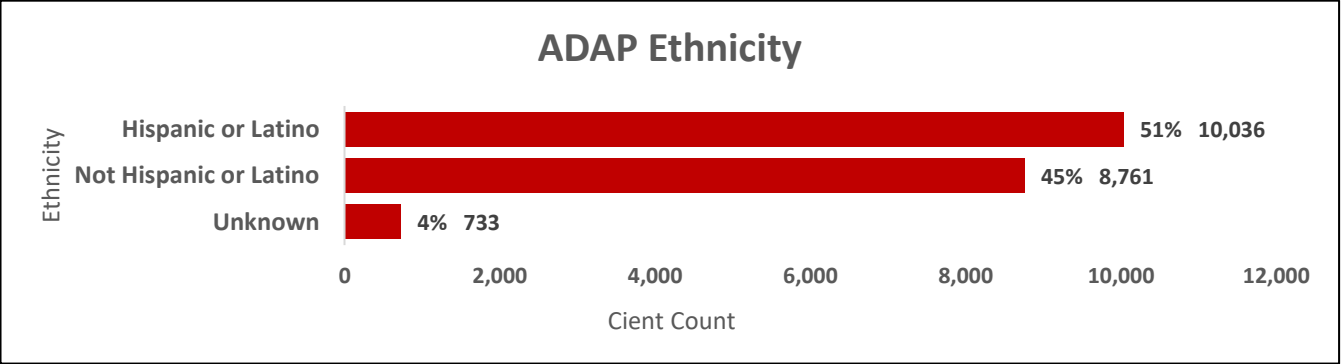
THMP Medications: March 2024 – May 2024

Total = 38,755



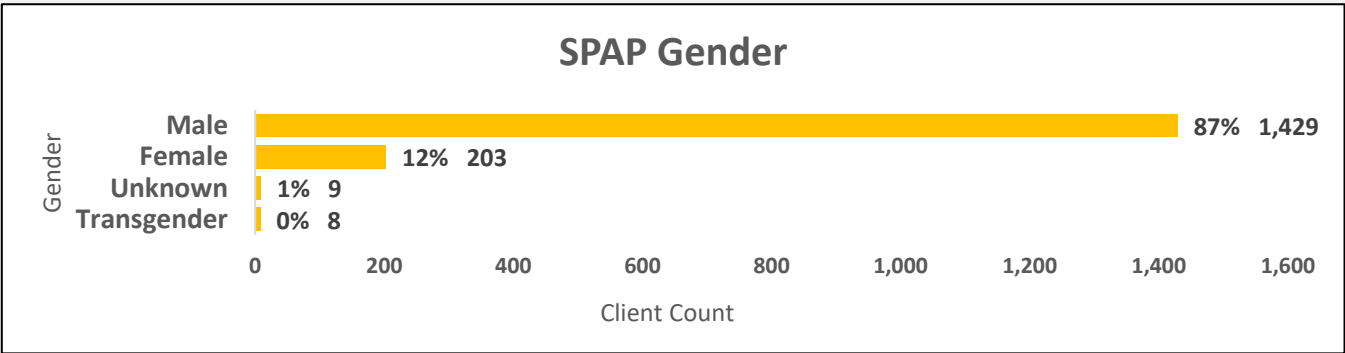
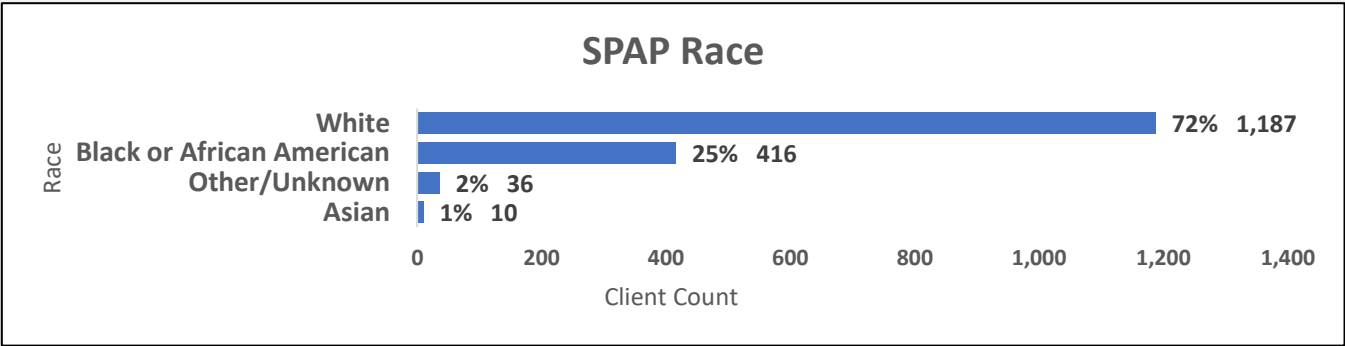
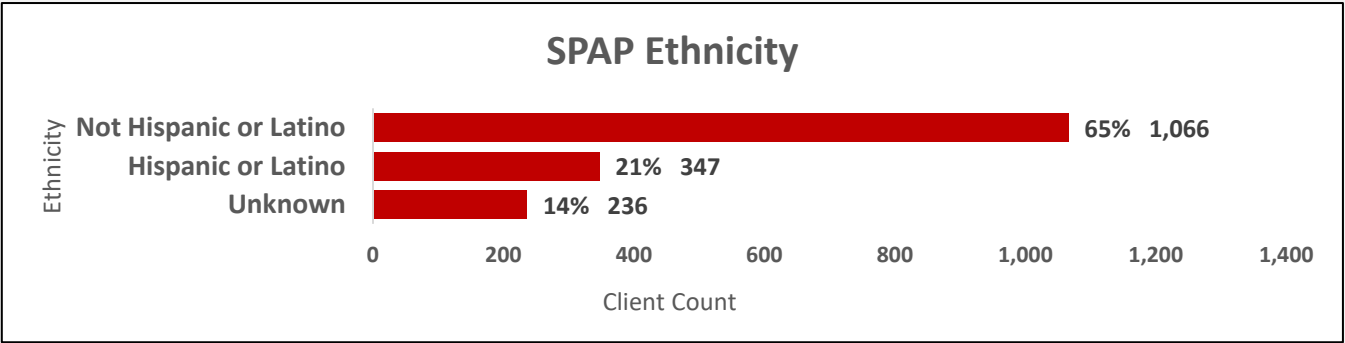
ADAP Demographics: March 2024 – May 2024

Total Clients with Medications Filled = 19,530



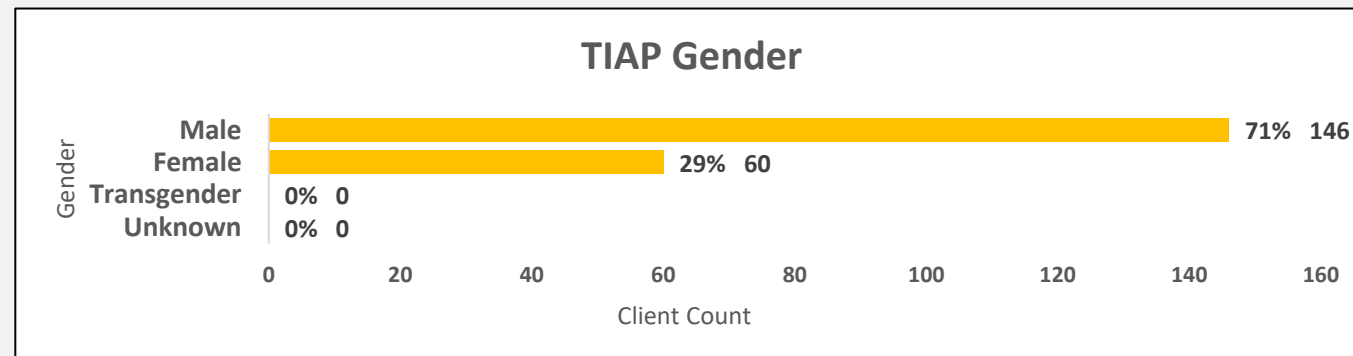
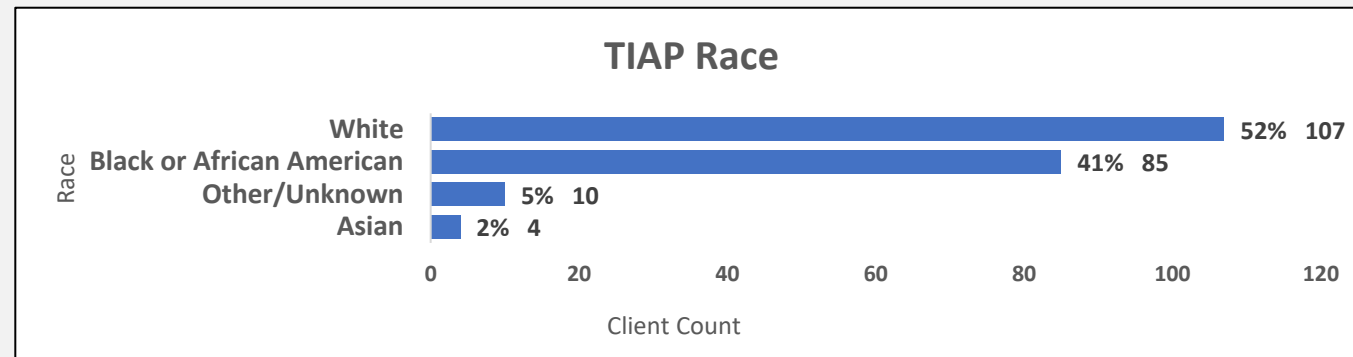
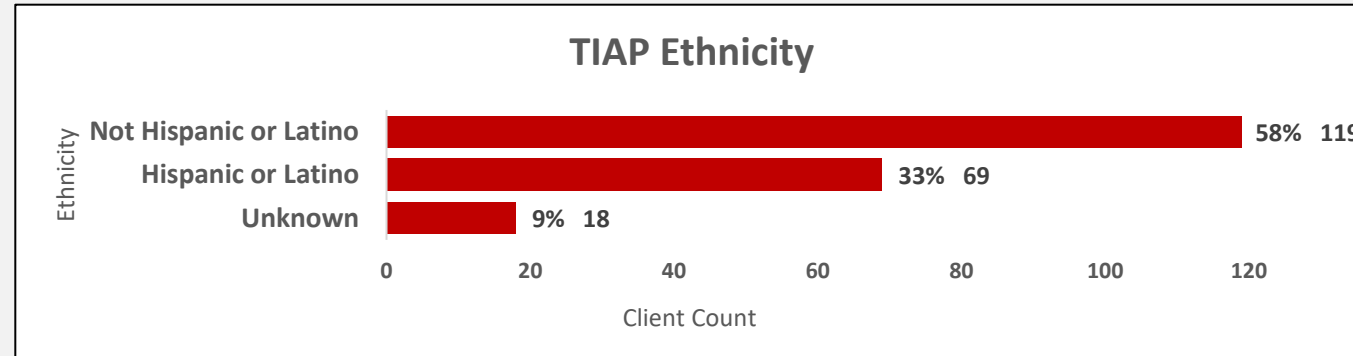
SPAP Demographics: March 2024 – May 2024

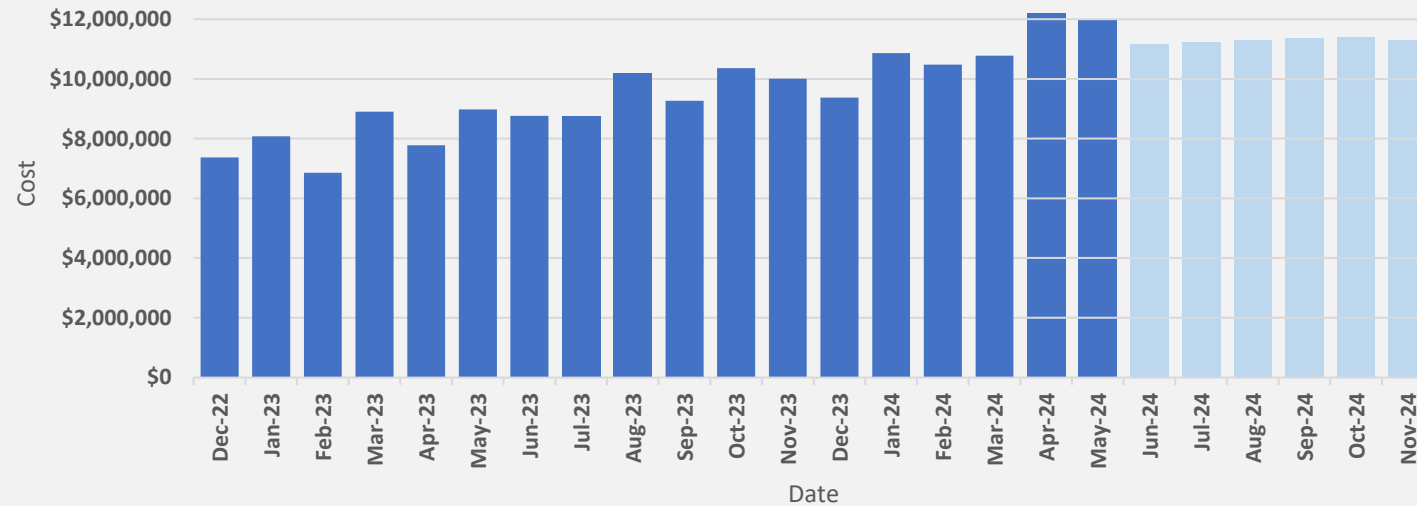

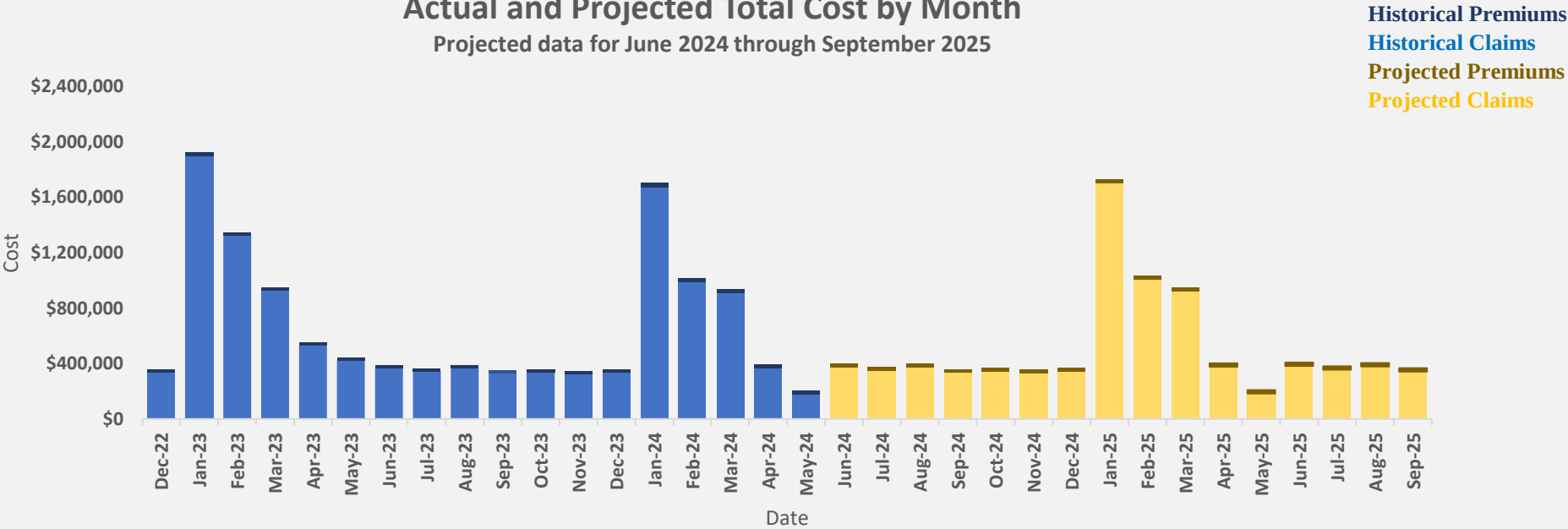

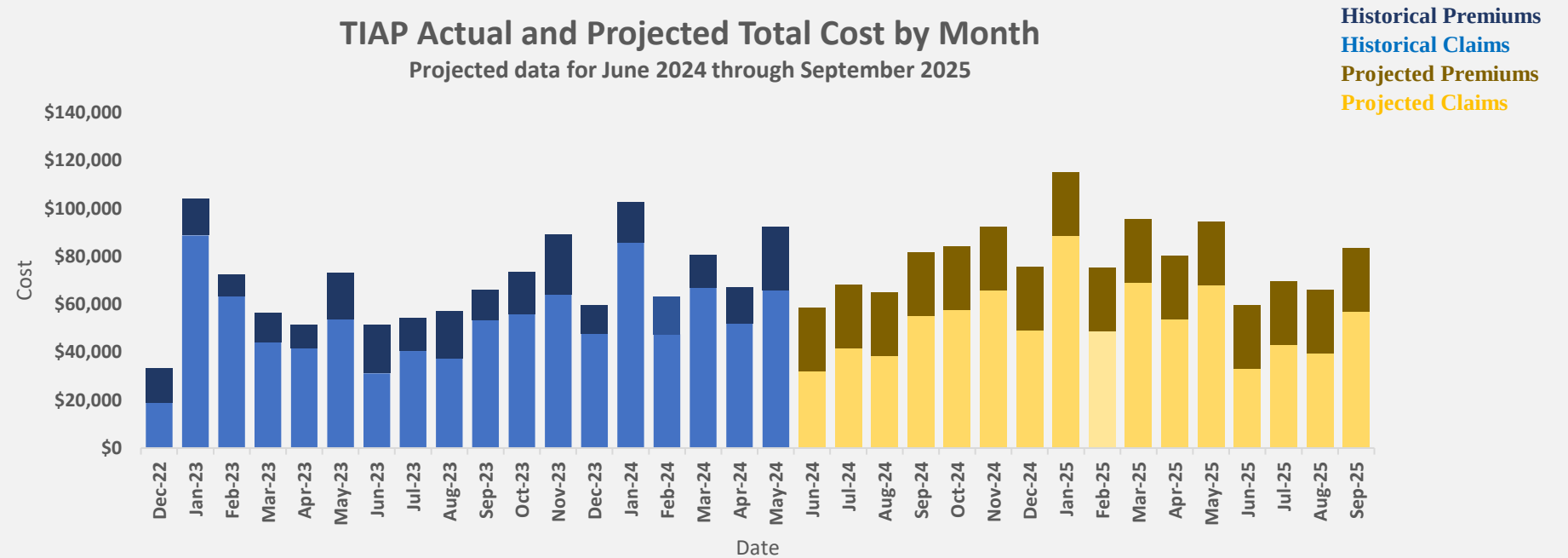
