

# 2017 Texas School Immunization Validation Survey Results: Vaccination Compliance Rates of Kindergarten and Seventh Grade Students Attending Texas Schools

## Kindergarten Students in Public Schools

The purpose of the 2017 Texas School Immunization Validation Survey was to assess the number of kindergarten students that were appropriately vaccinated in accordance with Texas school entry immunization requirements (Title 25 Health Services, Chapter 97, Texas Administrative Code §97.63). The Texas Education Agency reported that there were approximately 371,517 kindergarten students enrolled at approximately 4,462 Texas public schools during the 2017 – 2018 school year.

For the Texas School Immunization Validation Survey, a cluster sampling method was used to select 45 schools with kindergarten students. A random sample of 100 immunization records of kindergarten students was selected from each school.

The following table presents Texas statewide vaccination compliance rates for kindergarten students attending public school in Texas.

### Vaccination Compliance Rates of Texas Public School Kindergarten Students

- \* Requirements for kindergarten students: five doses of DTP/DTaP vaccine including one received on or after 4<sup>th</sup> birthday (four doses are acceptable if the 4<sup>th</sup> dose was received on or after the 4<sup>th</sup> birthday); four doses poliovirus vaccine including one received on or after 4<sup>th</sup> birthday (three doses are acceptable if the 3<sup>rd</sup> dose was received on or after the 4<sup>th</sup> birthday, or any combination of four doses of OPV and IPV received before four years of age is acceptable); one dose MMR vaccine received on or after 1<sup>st</sup> birthday and one additional dose of measles vaccine or 2<sup>nd</sup> MMR vaccine; two doses of varicella vaccine or history of disease; three doses of hepatitis B vaccine; and 2 doses of hepatitis A vaccine including one received on or after the 1<sup>st</sup> birthday.

# Kindergarten Students in Private Schools

The purpose of the 2017 Texas School Immunization Validation Survey was to assess the number of kindergarten students that were appropriately vaccinated in accordance with Texas school entry immunization requirements (Title 25 Health Services, Chapter 97, Texas Administrative Code §97.63). The Texas Private School Accreditation Commission reported that there were approximately 15,553 kindergarten students enrolled at approximately 883 Texas private schools during the 2017 – 2018 school year.

For the Texas School Immunization Validation Survey, a cluster sampling method was used to select 45 schools with kindergarten students. A random sample of 24 immunization records of kindergarten students was selected from each school.

The following table presents Texas statewide vaccination compliance rates for kindergarten students attending private school in Texas.

## Vaccination Compliance Rates of Texas Private School Kindergarten Students

\* Requirements for kindergarten students: five doses of DTP/DTaP vaccine including one received on or after 4<sup>th</sup> birthday (four doses are acceptable if the 4<sup>th</sup> dose was received on or after the 4<sup>th</sup> birthday); four doses poliovirus vaccine including one received on or after 4<sup>th</sup> birthday (three doses are acceptable if the 3<sup>rd</sup> dose was received on or after the 4<sup>th</sup> birthday, or any combination of four doses of OPV and IPV received before four years of age is acceptable); one dose MMR vaccine received on or after 1<sup>st</sup> birthday and one additional dose of measles vaccine or 2<sup>nd</sup> MMR vaccine; two doses of varicella vaccine or history of disease; three doses of hepatitis B vaccine; and 2 doses of hepatitis A vaccine including one received on or after the 1<sup>st</sup> birthday.

## Seventh Grade Students in Public Schools

The purpose of the 2017 Texas School Immunization Validation Survey was to assess the number of 7<sup>th</sup> grade students that were appropriately vaccinated in accordance with Texas school entry immunization requirements (Title 25 Health Services, Chapter 97, Texas Administrative Code §97.63). The Texas Education Agency reported that there were approximately 400,359 7<sup>th</sup> grade students enrolled at approximately 3,180 Texas public schools (excluding most alternative education programs) during the 2017 – 2018 school year.

For the Texas School Immunization Validation Survey, a cluster sampling method was used to select 45 schools with 7th grade students. A random sample of 100 immunization records of 7<sup>th</sup> grade students was selected from each school.

Vaccination compliance rates for 7<sup>th</sup> grade students were high for all vaccine requirements. The following table presents Texas statewide vaccination compliance rates for 7<sup>th</sup> grade students attending public school in Texas.

### **Vaccination Compliance Rates of Texas Public School 7th Grade Students**

\* Requirements for 7<sup>th</sup> grade students: three doses of DTP/DTaP vaccine including one received on or after 4<sup>th</sup> birthday and 1 Tdap/Td booster within last 5 years; four doses of poliovirus vaccine including one received on or after 4<sup>th</sup> birthday (three doses are acceptable if the 3<sup>rd</sup> dose was received on or after the 4<sup>th</sup> birthday); two doses of measles-containing vaccine, and one dose each of rubella and mumps vaccine; two doses of varicella vaccine or history of disease; three doses hepatitis B vaccine; one dose of meningococcal vaccine; two doses of hepatitis A vaccine including one dose received on or after the 1<sup>st</sup> birthday.

## Seventh Grade Students in Private Schools

The purpose of the 2017 Texas School Immunization Validation Survey was to assess the number of 7<sup>th</sup> grade students that were appropriately vaccinated in accordance with Texas school entry immunization requirements (Title 25 Health Services, Chapter 97, Texas Administrative Code §97.63). The Texas Private School Accreditation Commission reported that there were approximately 13,493 7<sup>th</sup> grade students enrolled at approximately 651 Texas private schools (excluding most alternative education programs) during the 2017 – 2018 school year.

For the Texas School Immunization Validation Survey, a cluster sampling method was used to select 45 schools with 7th grade students. A random sample of 24 immunization records of 7<sup>th</sup> grade students was selected from each school.

Vaccination compliance rates for 7<sup>th</sup> grade students were high for all vaccine requirements. The following table presents Texas statewide vaccination compliance rates for 7<sup>th</sup> grade students attending private school in Texas.

#### Vaccination Compliance Rates of Texas Private School 7<sup>th</sup> Grade Students

- \* Requirements for 7<sup>th</sup> grade students: three doses of DTP/DTaP vaccine including one received on or after 4<sup>th</sup> birthday and 1 Tdap/Td booster within last 5 years; four doses of poliovirus vaccine including one received on or after 4<sup>th</sup> birthday (three doses are acceptable if the 3<sup>rd</sup> dose was received on or after the 4<sup>th</sup> birthday); two doses of measles-containing vaccine, and one dose each of rubella and mumps vaccine; two doses of varicella vaccine or history of disease; three doses hepatitis B vaccine; one dose of meningococcal vaccine; two doses of hepatitis A vaccine including one dose received on or after the 1<sup>st</sup> birthday.
