2022 Texas School Immunization Validation Survey Results: Vaccination Compliance Rates of Kindergarten and Seventh Grade Students Attending Texas Schools

Kindergarten Students in Public Schools

The 2022 Texas School Immunization Validation Survey assessed the number of kindergarten students that were enrolled in accordance with Texas school entry immunization requirements (Title 25 Health Services, Chapter 97, Texas Administrative Code §97.63). The Texas Education Agency (TEA) reported that there were approximately 361,524 kindergarten students enrolled at approximately 4,836 Texas public schools during the 2022–2023 school year.

For the Texas School Immunization Validation Survey, the Department of State Health Services (DSHS) used a cluster sampling method to select 45 schools with kindergarten students. School Compliance staff then selected a random sample of 100 immunization records of kindergarten students from each school.

Kindergarten Students in Private Schools

The 2022 Texas School Immunization Validation Survey assessed the number of kindergarten students that were enrolled in accordance with Texas school entry immunization requirements (Title 25 Health Services, Chapter 97, Texas Administrative Code §97.63). The Texas Private School Accreditation Commission (TEPSAC) reported that there were approximately 20,156 kindergarten students enrolled at approximately 1,193 Texas private schools during the 2022-2023 school year.

For the Texas School Immunization Validation Survey, DSHS used a cluster sampling method to select 45 schools with kindergarten students. School Compliance staff then selected a random sample of 24 immunization records of kindergarten students from each school.

Seventh Grade Students in Public Schools

The 2022 Texas School Immunization Validation Survey assessed the number of 7th grade students that were enrolled in accordance with Texas school entry immunization requirements (Title 25 Health Services, Chapter 97, Texas Administrative Code §97.63). The TEA reported that there were approximately 421,800 7th grade students enrolled at approximately 3,250 Texas public schools (excluding most alternative education programs) during the 2022–2023 school year.

For the Texas School Immunization Validation Survey, DSHS used a cluster sampling method to select 45 schools with 7th grade students. School Compliance staff then selected a random sample of 100 immunization records of 7th grade students from each school.

Seventh Grade Students in Private Schools

The 2022 Texas School Immunization Validation Survey assessed the number of 7th grade students that were enrolled in accordance with Texas school entry immunization requirements (Title 25 Health Services, Chapter 97, Texas Administrative Code §97.63). The TEPSAC reported that there were approximately 17,845 7th grade students enrolled at approximately 802 Texas private schools (excluding most alternative education programs) during the 2022–2023 school year.

For the Texas School Immunization Validation Survey, DSHS used a cluster sampling method to select 45 schools with 7th grade students. School Compliance staff selected a random sample of 24 immunization records of 7th grade students from each school.
