- Registry = Texas Immunization Registry
- Orgs = Providers, healthcare entities, organizations

What is **BiDX** Production?

- Production is live BiDX
- Real records exchanged with the Registry
 - No more test records
- Ongoing live connection



Credentials

- Credentials sent to POC
 - Includes production webservices URL
- Testing credentials disabled
 - ImmTrac2 Test access disabled



FTP Changes – New Orgs

- FTP account created
 - FTP website
- Receive Folder
 - Contains CNF reports
- Consent Notification Files
 - List of patients' registry consent status



FTP Changes – Existing Orgs

- Plan final upload date
- FTP folders removed:
 - HL7-Dropoff, Accepted, and DQA Reports
 - Create backups of files
- Received folder remains for CNFs
- Monitor CNFs regularly



Sending Production Files

- Confirm "Go-Live" date
- Query Request
 - Send history requests as needed
 - Response from registry sent in real time
- Immunization Record Updates
 - Send immunization records in real time
 - Both New and Historical
 - Records added to registry in real time



Registry Consent – VXU Orgs Only

- Registry consent must go live with BiDX
- Consent workflow ready
- Send Consent regularly
 - Flat Files Send before vaccine records
 - HL7 Send with first the first vaccine record



Monitoring & Maintenance

- Develop monitoring and maintenance workflows
- Regularly monitor BiDX activity
 - Messages sent and received successfully
 - Review errors returned
- Address data quality errors promptly
 - The registry is a shared resource
- Contact the registry if assistance is needed



ImmTrac2 Website

- ImmTrac2 Website still needed
- Run Reports
 - Custom ad-hoc reports
 - TIPS report
- Site Renewal every two years
- Register new sites added to Org
