

TEXAS RADIATION ADVISORY BOARD MINUTES

MEDICAL COMMITTEE

Friday, January 31, 2025 Scheduled to convene at 9:00 a.m.

1. Call to Order

Darlene Metter, M.D., Chair, called the meeting to order at 9:03 a.m. A quorum was present.
