TOPIC RESEARCH COMMITTEE

Friday, January 20, 2023 8:00 a.m.

1. Call to Order

- 2) <u>Advisory Statement on Storage of Spent Nuclear Fuel in Texas</u> This statement was reviewed and discussed. Mr. Powell motioned to move this statement to the INUW committee with the comments that this committee made. Mr. Hageman seconded this motion. All agreed.
- 3) <u>Advisory Statement on Sealed Source Disposal</u> This statement was reviewed and discussed. Mr. Powell motioned to pass this statement on to the Medical and INUW committees for further review. Mr. Hageman seconded the motion. All agreed.
