MEDICAL COMMITTEE

Friday, April 21, 2023 9:00 a.m.

1. Call to Order

5. Routine and Continuing Business: A. Status on upcoming rule revisions

- i. 25 TAC § 289.229 Radiation Safety Requirement for Accelerators, Therapeutic Radiation Machines, Simulators, and Electronic Brachytherapy Devices
- ii. 25 TAC § 289.301 Registration and Radiation Safety Requirements for Lasers and Intense-Pulsed Light Devices
- iii. Update on DSHS review of RAM and NRC rules

B. CRCPD suggested regulations – Part X (Radiation Treatment Rules for suggested State Regulatory Groups) document likely published in 2023 Mid-Summer: Status of Public Comments (DSHS – Lisa Bruedigan) Ms. Bruedigan reported on the progress of these regulations. She stated that it is at federal concurrence at this time. It has gone through peer review and put out for public comment. Several public comments were received and reviewed. The final version has been drafted and accepted by peer review and is waiting on federal concurrence before it is published on the CRCPD website.

C. Update on Nuclear Regulatory Commission (NRC)/Advisory Committee on Medical Uses of Isotopes (ACMUI) subcommittee on the American Board of Radiology's relinquishment of NRC Recognition

Dr. Metter gave an update on this topic.

6. New Business

A. 2023 Strategic Plan Update (All)

The Medical Committee portion of the 2023 Strategic Plan was presented to the committee. After discussion, some edits were made to this portion of this Strategic Plan. Dr. Posey motioned to accept the 2023 Strategic Plan with the suggested corrections. Dr. Masters seconded this motion. All approved.

B. Review Review of Position Statement on Sealed Source Disposal referred by full TRAB (All)

Ms. Bruedigan stated that TCEQ gave some comments on this document. Still, they asked for more time to look at it after the legislative session. It was decided to table this topic until the next meeting.

Shannon Quinn, DSHS, presented the DSHS inspectors' checklist when inspecting veterinary facilities. This checklist is available on the DSHS website and will also be linked under Dr. Posey's name on the TRAB website.
