## Agenda Item 1: Call to order, welcome, Chair remarks, meeting logistics, and roll call

Dr. Arturo Rodriguez, Chair, convened the TFBHO meeting at 1:00 p.m., and welcomed attendees. Ms. Francesca Kupper, Program Specialist, Advisory Committee Coordination Office (ACCO), Texas Health and Human Services Commission (HHSC), provided logistical announcements, conducted the roll call, and noted a quorum was present. Dr. Rodriguez requested a minute of silence for the victims of recent flooding events in Central Texas.

# **Agenda Item 2:** Consideration of June 11, 2025, draft meeting minutes Dr. Rodriguez called for any edits or changes to the June 11, 2025, draft meeting minutes. Receiving no edits or changes, Dr. Rodriguez called for a motion to approve the draft.

#### **MOTION:**

Dr. Veerinder Taneja moved to approve the June 11, 2025, draft meeting minutes as written. Ms. Shannon Harvill seconded the motion. The motion was unanimously approved with no nays nor abstentions.

# **Agenda Item 3:** Recognition of outgoing Chair, Dr. Arturo Rodriguez Dr. Jennifer Shuford, DSHS Commissioner, provided recognition of outgoing TFBHO Chair

Dr. Rodriguez and thanked him for his service to the people of Texas.

#### Agenda Item 4: 89th Legislative Session update

Mr. Daniel Knapp, Government Affairs Specialist, DSHS, reviewed the PPT titled, "TFBHO Legislative Update". The presentation included the budget & exceptional items for DSHS and selected bill highlights. The highlighted bills were related to the modification of the Texas border region definition (HB 1240) which would increase the number of TFBHO members, as well as the total THC ban for hemp, Make Texas Healthy Again, vaccine & immunizations, electronic health records, and rural health stabilization and innovation.

### Agenda Item 5: Texas A&M Colonia Safe Water Project

Dr. Taehyun Roh, Assistant Professor, School of Public Health, Texas A&M University, reviewed the PPT titled, "Safe Drinking Water in Texas Border Communities". Key points included:

- Arsenic is an invisible poison that can leach into groundwater and increases the risk of various diseases.
- Target strategies, such as identifying high risk groups and providing interventions and tools for early detection, are essential in areas with high arsenic exposure from drinking water.
- The current project in Rio Grande Valley colonias aims to empower the communities, strengthen partnerships, and lay the foundation for long-term improvement.

## Agenda Item 6: Addressing the health workforce pipeline

Ms. Courtney Dezendorf, Director, and Ms. Emily Herrington, Texas Public Health Fellowship Program Manager, both from Office of Practice and Learning, DSHS, reviewed the PPT titled, "Public Health Workforce Pipeline". Highlights included:

- Hosting interns, fellows, and residents can provide early to mid-career level staff the opportunity to learn and hone management skills.
- 16 out of 99 fellows over past 3 years were placed in host sites in border region.
- Providing meaningful experiential learning opportunities for students and regularly connecting with academic partners can help fill current and future workforce needs.

#### Agenda Item 7: Hidalgo County opioid initiatives

Ms. Amy Gonzalez, Lead Epidemiologist, Hidalgo County Health & Human Services, reviewed the PPT titled "Opioid Awareness & Prevention Initiatives in Hidalgo County". Key points included:

- A community health assessment allowed the county to look at information needs related to opioids and the use of naloxone.
- Behavioral Health Solutions of South Texas is accepting applications to install Narcan vending machines in local health departments or community health centers.
- Partners at the South Texas High Intensity Drug Trafficking Areas Program Task Force provide trainings on drug-trends, overdose identification and Narcan distribution and use.
