"Community health fairs & We participate in 2 community health fairs per year for patients 55 and older. We provide health screenings for cholesterol, glucose, blood pressure and education for health care in general and specific conditions found in the screenings. Dinner Bell ¿ We participate 3-4 times per year in serving meals the homeless through an outside organization. CAN Help Back to School -We administered blood pressure checks and gave out information on school safety check sheets and home fall safety checklist along with giveaways. Farmers Electric Co-op Event ¿ We participated in this event by administering blood pressure checks and gave out information flyers and giveaways. Heart Healthy Event - We coordinated this event with a presentation by our local cardiologist, along with question and answer session and a tour of the cath lab. Stroke Event ¿ We coordinated this event with a presentation by one of our providers. This event included stroke information and our Code Stroke designation. Participants were offered blood pressure and all types of other health information. BIBS Support Group - This is a monthly group that meets to offer support to our new moms. The coordinator offers different speakers/topics each month. Blood Drives ¿ Our hospital coordinates 4 blood drives a year with Carter Blood Care. College and Career Expo - Over 750 high school students attended various booths offered by our health care team from nursing, respiratory therapy, radiologic technologist and providers. Inmate Program ¿ We provide a physician once a week to see inmates in our county jail. These inmates are also provided medications as part of our charity program. Nursing Students ¿ Our hospital has an agreement with both Paris Junior College and Texas A and M in Commerce for nursing students to do training with our nursing team. Our nurse act in a preceptorship role for these students. Sports Medicine Program ¿ Our hospital implemented in coordination with CHRISTUS Mother Frances Hospital in Tyler a Sports Medicine Trainer Program. We have a sports trainer who is involved with all local schools in our area for education, treatment and coordination of care as needed for all students. We also have a sports trainer in our orthopaedic clinic. "
