Mobile Mammography Unit ¿ Provides free mammograms to women without insurance or the ability to pay. Women, Infant, and Children (WIC) Program & Supplemental nutrition, breastfeeding education and support program. Center for Miracles ¿ Assess children who are suspected victims of abuse or neglect. Ronald McDonald House & In-kind Space dedicated to Ronald McDonald house residential, Physician Recruitment ¿ Fills need in Medically Underserved Area (MUA) and Health Professions Shortage Area. CMS Innovation Center Accountable Health Communities (AHC) Grant ¿ Screening for social determinants of health for Medicare or Medicaid beneficiaries. The Southwest Texas Regional Advisory Council (STRAC) launched the Southwest Texas Crisis Collaborative (STCC) ¿ Aimed at transforming health care delivery, improving care, and reducing the cost of care for the Homeless, Mental Illness and Super Utilizers.
