Children's Mobile Unit & Provide well child, sick child, and immunizations in school districts. Culinary Health Education for Families Program (CHEF) ¿ Teaches children and families common sense nutrition and practical cooking skills. Mobile Mammography Unit ¿ Provides free mammograms to women without insurance or the ability to pay. Enroll SA Coalition ¿ Coalition focused on maximizing enrollment in the Health Insurance Marketplace created by the ACA. Women, Infant, and Children (WIC) Program & Supplemental nutrition, breastfeeding education and support program. Center for Miracles ¿ Assess children who are suspected victims of abuse or neglect. Ronald McDonald House & In-kind Space dedicated to Ronald McDonald house residential, Physician Recruitment ¿ Fills need in Medically Underserved Area (MUA) and Health Professions Shortage Area. CMS Innovation Center Accountable Health Communities (AHC) Grant ¿ Screening for social determinants of health for Medicare or Medicaid beneficiaries. The Southwest Texas Regional Advisory Council (STRAC) launched the Southwest Texas Crisis Collaborative (STCC) ¿ Aimed at transforming health care delivery, improving care, and reducing the cost of care for the Homeless, Mental Illness and Super Utilizers.
