The Mission of Mercy Laboratory program is in collaboration with the Corpus Christi Mission of Mercy non-profit health clinic. Spohn completes all required laboratory needs (blood work) for any Mission of Mercy patient (that is referred to us) free of charge. The target population is the vulnerable and underserved community. The purpose is to increase access to care and decrease preventable hospitalizations. 3. The Community Health and Development department provides patients with access to one-on-one health education, navigation assistance, and clinical access assistance. The purpose is to assist our population in the self-management of chronic diseases, increase access to care, and decrease preventable hospitalizations. 4. The Coastal Bend Neighborhood Empowerment activity is a collaborative effort that is striving for the sustainable development and healthy outcomes of neighborhoods and communities based on the asset based community development principals. The target population is the vulnerable and underserved community. The purpose is to decrease preventable hospitalizations and participate in community planning.
