Agenda Item 1: Welcome and Introductions

Ms. Minerva Garcia, Chair, called the meeting to order at 10:07 a.m. and welcomed members and attendees. Ms. Garcia, Chair, reminded committee members to turn on video camera and unmute their mics and state their names each time before offering a comment or asking a question so members of the public know who's speaking.

Mr. John Chacón, Advisory Committee Coordination Office, Facilitator, provided meeting logistics and announced the meeting was being conducted in accordance with the Texas Open Meetings Act in a Teams virtual platform and on-site at the Moreton M100 Public Hearing Room. Mr. Chacón called roll and asked each member to briefly introduce themselves. A quorum of members was established with only one member not in attendance.

Ms. Garcia, Chair, asked the Department of State Health Services (DSHS) staff to introduce themselves. Mr. Frank Luera, and Ms. Raiza Ruiz, and Brett Spencer introduced themselves to the committee.

Agenda Item 2: Consideration of April 29, 2022 and July 29, 2022, draft meeting minutes

Ms. Minerva Garcia, Chair, announced that the April 29, 2022 and July 29, 2022 minutes were provided to members and for them to locate them in the electronic packets. Ms. Garcia asked for any edits or comments to either sets of minutes. Hearing none, Ms. Garcia asked for a motion to accept the minutes as presented.

MOTION:

Dr. Carolina Gonzalez Schlenker made the motion to accept both sets of minutes as presented with a second from Ms. Monica Hughes. Mr. John Chacón conducted a roll call vote of the committee members. With a unanimous vote of the committee, eight approvals, no disapprovals, and no abstentions, the motion carried

Agenda Item 3: Health Promotion and Chronic Disease Prevention Section Update

Ms. Garcia, chair, introduced Ms. Raiza Ruiz, DSHS, Manager, Community Health Worker and School Health Branch to provide an update to the committee.

Highlights of updates included:

- DSHS Updates
 - The Texas Department of State Health Services Commissioner, Dr. Hellerstedt retired on September 30, 2022. He served in this role since January 2016.
 - $\circ~$ Dr. Jennifer Shuford is now serving as interim commissioner.
 - The job posting for the Administrative Assistant position with the Community Health Worker Training and Certification Program closed on 10/21.
 Management is currently screening applications and interviewing and hopes to fill the vacancy soon.
- Substance Abuse and CHWs
 - The CHW Program has been invited to participate in a collaborative meeting on November 9, 2022, between the Health and Human Services Commission and the Texas Department of State Health Services Texas Targeted Opioid Response (TTOR) team. Holding this monthly meeting is one of the initiatives in the DSHS Action Plan to Address Substance Use.
 - Substance use is a complex problem with devastating and lasting effects.
 Given the current increase in overdose deaths due to fentanyl and other opioids, DSHS took this opportunity to highlight some DSHS certified trainings related to substance abuse.
 - The DSHS CHW Program has certified various training curriculums on this topic, including:
 - Introduction to Opioid Use Disorder for CHWs, by South Coastal Area Health Education Center Program.
 - Project ECHO Opioid Addiction Treatment Intro for CHWs, by South Coastal Area Health Education Center Program.
 - Co-occurring Substance Use and Behavioral Health Disorders for CHWs, by South Coastal Area Health Education Center Program.
 - The Opioid Abuse Epidemic: The roles CHWs can play, by West Texas Area Health Education Center Program.
 - Addiction, by West Texas Area Health Education Center Program.
 - DSHS encourages CHWs to look for those training opportunities. You may find the contact information for the training centers on the DSHS website.

- Letter of Support
 - The DSHS Health Promotion and Chronic Disease Prevention Section provided a letter of support for Tarleton State University's Rural Communication Institute (RCI)'s proposal for funding from the Health Resources and Services Administration (HRSA-23- 030).

This proposal is to expand the infrastructure and capacity building initiatives to serve older adults in the rural and historically undeserved areas of Texas through Community Health Workers (CHWs). RCI will establish a Rural Public Health Center at the main campus of Tarleton State University in Stephenville, Texas and seeks to establish a DSHS-certified training center focusing on developing rural and geriatric health curriculum to integrate in the formal training of CHWs to positively impact the health outcomes of the adults in the rural areas of Texas. With this approach, CHWs will have more tools in their toolbox when acting as a liaison between community members and providers and addressing disparities concerning rural older adults' health.

 - A CHW or Promotor(a) member must be currently certified by DSHS as required by Texas Administrative Code §§146.1-146.8.

Agenda Item 4: Election of Presiding and Assistant Presiding Officers

Agenda Item 4 Cont'd: Consideration of Officer Election Procedure and Election of officers

Mr. Chacón read the nominations for Presiding Officer received by the program area email prior to the meeting. Ms. Minerva Garcia, self-nominated and Ms. Ashley Rodriguez, selfnominated. Mr. Chacón asked the two nominees if they accepted the nomination, then called for any additional nominations from the floor for Presiding Officer. Hearing none, Mr. Chacón asked Ms. Garcia to provide her qualifications to serve as presiding officer followed by Ms. Ashley Rodriguez informing members of her qualifications. Mr. Chacón called for a vote of each member to announce their candidate of choice.

With five (5) votes for Ms. Minerva Garcia and four (4) for Ms. Ashley Rodriguez, Ms. Garcia was reelected to serve as presiding officer for the Promotor(a) or Community Health Worker Training and Certification Advisory Committee

Mr. Chacón announced no nomination were received for the assistant presiding officer prior to the meeting and opened the floor up for nominations. Ms. Ashley Rodriguez, selfnominated. Mr. Chacón then called for any additional nominations from the floor for assistant presiding officer, hearing none he closed the nominations to a single nominee. Mr. Chacón called for a motion to elect Ms. Ashley Rodriguez by acclamation

Ms. Minerva Garcia made the motion with Ms. Tasha Whitaker seconding the motion to elect Ms. Ashley Rodriguez as the assistant presiding officer for the Promotor(a) or Community Health Worker Training and Certification Advisory Committee. With unanimous vote of the committee Ms. Ashley Rodriguez was elected as assistant presiding officer for the Promotor(a) or Community Health Worker Training and Certification Advisory Committee.

Agenda Item 5: Update from Texas Association of Promotores & Community Health Workers

Ms. Garcia, chair, introduced Ms. Ashley Rodriguez, CCHW, CCHWI, President of the Board of Directors to provide a statewide update on the Texas Association of Promotores & Community Health Workers and referenced a PowerPoint titled "Texas Association of Promotores & Community Health Workers".

Highlights of the update included:

- Ms. Rodriguez provided a brief history that began in 2015 and listed key milestones.
 - Official Launch 2019
 - 1st Conference 2020
 - Training Center Launch 2021
 - Ability to offer 30 Continuing Education hours (CE) 2021
 - Statewide Partnerships to advocate for the Workforce.
- Local association calls and training center calls monthly
- Findings from the 3rd annual conference
 - Number of Participants were low perhaps due to widely available CEUs around the state.
 - Location not convenient
 - Timing other conferences offered prior to the 2022 conference
 - There was low participation in Spanish classes
 - Umemba Health training center taught a CEU

Agenda Item 6: Update from South Texas Promotores Association

Ms. Garcia, chair, introduced Ms. Otila Garcia to present members with an update on the South Texas Promotores Association

- The South Texas Promotores Association is a nonprofit organization composed by over 500 members that provide services to the South Texas border communities.
