Order Placing N-ethylpentylone into Schedule I Temporarily Listed Substances

The Acting Administrator of the Drug Enforcement Administration issued an order temporarily placing the synthetic cathinone 1-(1,3-benzodioxol-5-yl)-2-(ethylamino)-pentan-1-one (other names: N-ethylpentylone, ephylone) and its optical, positional, and geometric isomers, salts, and salts of isomers into schedule I of the Controlled Substances Act effective August 31, 2018. This temporary scheduling

order was published in the *Federal Register*; Volume 83, Number 170, pages 44474-44478. This action was based on the following:

- 1. N-ethylpentylone has a high potential for abuse;
- 2. N-ethylpentylone has no currently accepted medical use in treatment in the United States;
- 3. N-ethylpentylone has a lack of accepted safety for use under medical supervision; and,
- 4. Temporarily placement of N-ethylpentylone into schedule I is necessary to avoid an imminent hazard to the public safety.

Pursuant to Section 481.034(g), as amended by the 75th legislature, of the Texas Controlled Substances Act, Health and Safety Code, Chapter 481, at least thirty-one days have expired since notice of the above referenced action was published in the *Federal Register*. In the capacity as Commissioner of the Texas Department of State Health Services, John Hellerstedt, M.D., does hereby order that the substances N-ethylpentylone be temporarily placed into schedule I.

SCHEDULE I

-Schedule I temporarily listed substances subject to emergency scheduling by the United States Drug Enforcement Administration.

Unless specifically excepted or unless listed in another schedule, a material, compound, mixture, or preparation that contains any quantity of the following substances or that contains any of the substance's optical, positional, geometric isomers, salts, isomers, and salts of isomers if the existence of the salts, isomers, and salts of isomers is possible within the specific chemical designation.
