EMS COMPLIANCE FY 2025 ANALYSIS FINAL ENFORCEMENT ACTIONS



Pursuant to 25 Texas Administrative Code 1.553(a)(1)(2)

EMS Policy & Procedure Requirements

Emergency Medical Services (EMS) is a crucial factor of the health care system in the State of Texas. EMS professionals can be broadly categorized as Providers and Personnel. EMS Providers maintain EMS vehicles, medical equipment, and EMS personnel to provide emergency medical services. EMS Personnel through EMS Providers unilaterally function to save countless lives each year when they respond to calls for emergency medical needs. The Department of State Health Services (DSHS) Compliance Branch oversees the enforcement of regulatory services pertaining to EMS Personnel, EMS Providers, EMS Education Programs, EMS Continuing Education (CE) Programs, EMS Educators, and First Responder Organizations (FRO) to ensure sustenance of quality services, compliance, safety, and the general well-being of the Texans at large via enforcement, compliance, and accountability to and of all applicable statutes, laws, rules, and regulations.

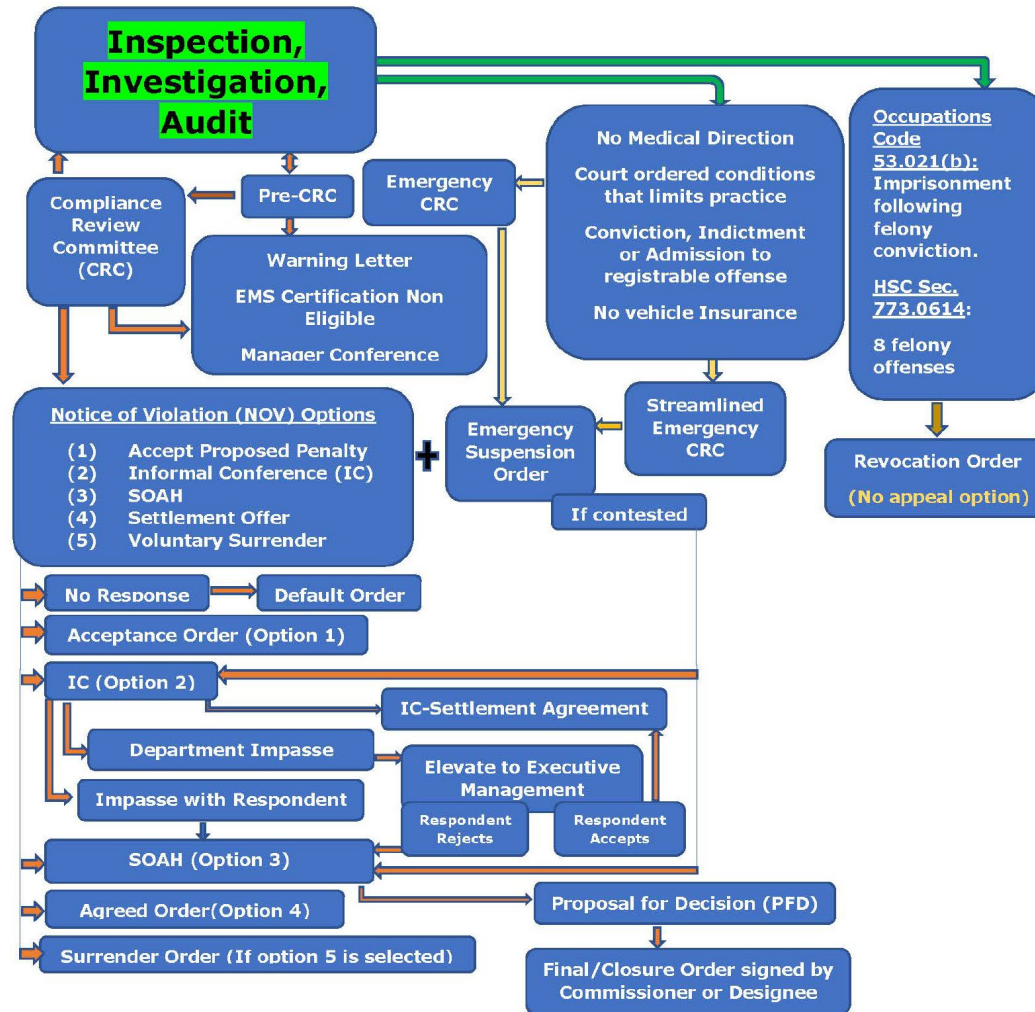

Types of Disciplinary Actions Proposed in an NOV

Monetary fine(Providers), Revocation, Suspension, Reprimand and Denial

Types of Order/ Agreement

(with or without conditions)

Monetary fine, Revocation, Suspension, Probated Suspension, Reprimand, Voluntary Surrender, Denial (Initial/Renewal), Reinstatement and Non-disciplinary Agreement

Cases referred to Compliance

- cases were referred in total:
 - 88 through Compliance Review Committee (CRC)
 - 31 through Emergency CRC
 - 5 through Streamlined CE Audit (bypass CRC)

CRC	88
Emergency CRC	31
Streamline CE Audit	5
Total	124

Outcomes

After triage at CRC:

- 23 cases were returned to program
- 59 Notice of Violation (NOV) letters were cleared to be issued

After Emergency CRC:

- 23 cases resulted in emergency suspension orders issued

After streamline submission:

- 0 cases were returned to program

Informal Conference (IC)

28 cases were heard at an IC:

- 23 Cases were settled after the IC
- 2 Cases were referred to the State Office of Administrative Hearings
- 1 Closed with Revocation by operation of law
- 1 Closed with Revocation pursuant to Administrative Procedure Act Texas Government Code Chapter 2001
- 1 Pending outcome



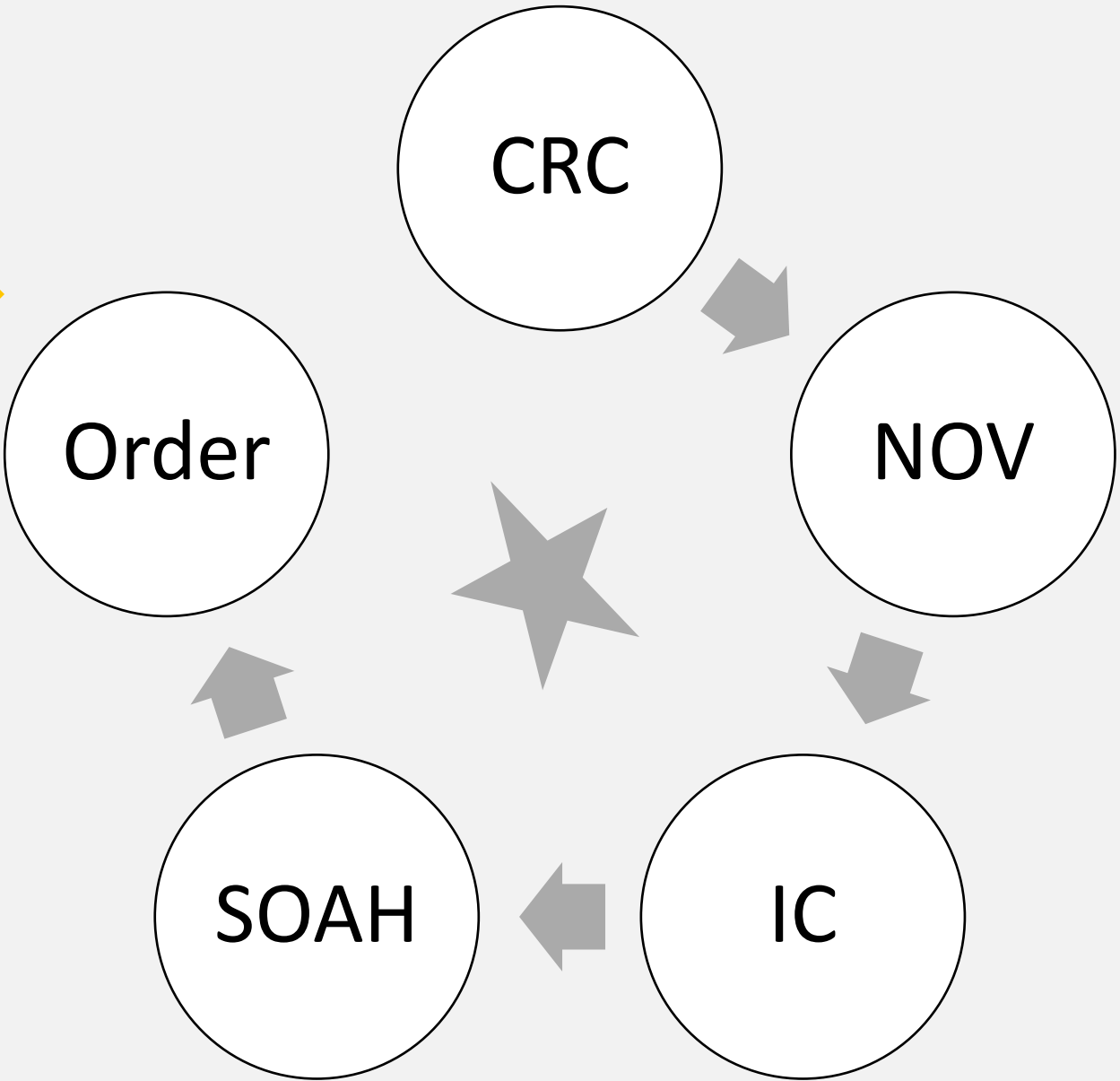

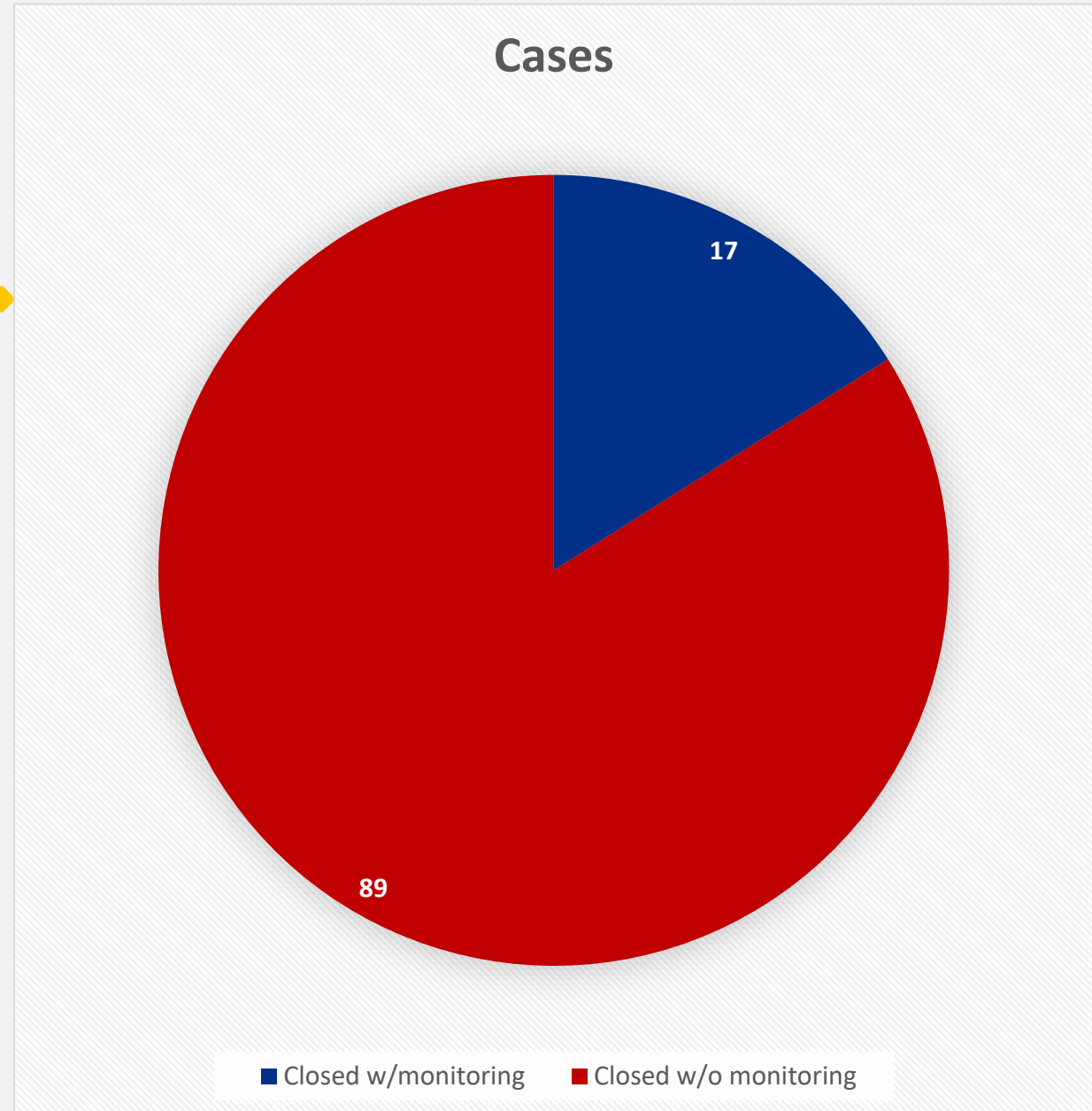


- 6 Agreed Orders (AO) / Acceptance Order of Agreement (AOA) - all personnel

 - 15 EMS Personnel
 - 1 EMS Provider
- 17 Informal Conference Settlement Agreement (ICSA) / Settlement Agreement (SA)
 - 14 EMS Personnel
 - 3 EMS Provider

Cases Closed With or Without Monitoring

Cases that have a finalized Order or an Agreement are either:

- Closed with monitoring
 - Terms or conditions to be monitored and can not be completely closed until terms are met
- Closed without monitoring
 - No terms or conditions – case closed
