

MSA Program Overview

MSA program partners with the people, communities, and meat and poultry industries to protect, promote, and improve health. The program accomplish the mission by regulating and enforcing public health laws and policies necessary to prevent disease and protect the public's well-being. These efforts assure Texans that products bearing the Texas mark of inspection are produced from healthy animals that are slaughtered in a humane manner and prepared in a sanitary environment, contain no harmful ingredients, and are truthfully labeled.

Compliance/Disciplinary Actions are taken in response to a violation of MSA law or rules. Different kinds of actions can be taken depending on the severity of the offense, the history of previous violations, efforts made to correct the violation, the harm to the public, the likelihood of a repeat violation, and other matters related to each case. These actions are taken to protect and promote the health, safety and welfare of the citizens of Texas.
