What are FTP Data Exchange Methods?

- Data exchange Methods are the ways in which you can send immunization records to the registry.
- Three Methods
 - Automated Data Exchange
 - A 3rd Party FTP Client
 - The registry's FTP Website
- Choose the method that works best for your organization



Requirements (1 of 3)

- Data exchange account
- EHR must be able to create message using HL7 2.5.1
- Setup instructions covered in the Secure File Transfer Protocol Specifications guide



Requirements (2 of 3)

- Data exchange account is made of:
 - FTP Username
 - FTP Password
- A single shared account for your organization
 - Organization responsible for managing access
- Does not expire but may be changed



Requirements (3 of 3)

- Immunization record batch files naming guidelines
- ImportCodeYYDDD.hl7
 - ImportCode is your data exchange account username
 - **YY** is the current two-digit year
 - **DDD** is the three-digit Julian date
 - .hl7 is the file type
- Page 10 of the Electronic Data Exchange Resource Guide



Automated Data Exchange (1 of 2)

- Automated Data Exchange is a direct connection from your EHR to the registry
- Files are created by your EHR and sent without you moving them



Automated Data Exchange (2 of 2)

- Each EHR is different
- Training must be provided by your EHR vendor
 - Does your EHR retrieve error messages?
- Troubleshooting must be done by you EHR vendor



Using an FTP Client (1 of 2)

- HL7 Immunization files created in the EHR
 - Training from EHR vendor
- Files sent to the registry using a 3rd party File Transfer Protocol (FTP) client
 - Transfer the file to the HL7-Dropoff folder



Using an FTP Client (2 of 2)

- The registry does not provide 3rd party FTP clients
- FTP client set up and supported by your local IT
 - Training must be provided by your local IT
 - Local IT must participate in troubleshooting



The FTP Website (1 of 6)

- The FTP website is available to all data exchange partners
- You can send immunization files and retrieve error and informational files from the website.
- Link sent to POC with data exchange account
- HL7 immunization record files created by EHR



The FTP Website (2 of 6)

- It is important that someone from your organization (NOT only from your EHR vendor) familiarize themself with and regularly use the FTP website.
 - ALL organizations
 - Regardless of data exchange method
- Data Quality reports are found on the FTP website



The FTP Website (3 of 6)

- Log in to the FTP website using your data exchange account
- On the FTP website, you will see four folders:
 - HL7-Dropoff
 - Accepted
 - DQA-Reports
 - Receive



The FTP Website (4 of 6)

- *HL7-Dropoff*: Your organization delivers test files to this folder.
 - These files are moved to the *Accepted* folder by the registry.
- **Accepted**: Copies of your uploaded data files are stored here.



The FTP Website (5 of 6)

- **DQA-Reports**: Data Quality Assessment (DQA) reports are located in this folder for each data file processed by the registry.
 - Check for DQA reports regularly
- *Receive*: Consent Notification Files (CNF) are located in this folder listing your reported patients' registry consent status.



The FTP Website (6 of 6)

- Support for the FTP website is provided by the Texas Immunization Registry's ImmTrac2 support team.
 - Contact the registry directly
- Additional details can be found in the *Electronic Data Exchange Resource Guide*
