## Agenda Item 2: Consideration of May 10, 2024, Draft Meeting Minutes

**Motion:** Dr. Lawrence Thompson, Jr. moved to approve the minutes as presented from the May 10, 2024, meeting. Kathryn Sibley seconded the motion. Following a roll call vote, the motion passed by a majority vote with 10 yeas (Abraham, Anzaldúa, Hayes, Matthews, Murthy, Ross, Sibley, Smith, Thompson, Wu), 0 nays and six abstentions (Baldwin, Fletcher, Gonzalez, Howard, Kissoon, Tilman).

## Agenda Item 3: Consideration of Open SCFRT Position

Dr. Murthy announced this agenda item is to provide the six permanent SCFRT members the opportunity to consider and vote on the open SCFRT Committee position – Justice of the Peace. Ms. Francesca Kupper provided process and bylaw items. Ms. Sarah Blezinger, Injury Prevention Coordinator, Injury Prevention Unit, DSHS, introduced each justice of the peace applicant: Honorable B.J. Teer and Honorable Joanne Garcia Flores.

Ms. Kupper called on each of the six permanent members to record their individual vote for the justice of the peace member position:

Ms. Kathryn Sibley voted for Judge Garcia Flores.

The Honorable State Representative Gene Wu voted to abstain.

Ms. Kupper noted two votes approving the selection of Judge. Garcia Flores to the open SCFRT justice of the peace member position (T. Das, K. Sibley), two abstentions (M. Fletcher, Wu), and two absences (L. Martinez, L. Gabbert Charney) and announced Judge Garcia Flores was selected to fill the open justice of the peace member position.
