Agenda Item 3: Presentation: 2020-2021 Child Fatality Data

Chief Baldwin introduced Ms. Juliana Bushnell, Texas Department of State Health Services, Injury Prevention Unit Epidemiologist, who provided a PowerPoint presentation, "2020-2021 Child Fatality Data." Key points included:

- Texas child mortality trends from 2011-2021, including all cause mortality, external cause mortality, and natural cause mortality.
- 2020-2021 Leading causes of Texas child mortality.
- 2020-2021 Texas child mortality broken down by race and sex.
- 2020-2021 Five leading causes of Texas child mortality by age group for all causes, external cause mortality, and unintentional mortality.

Ms. Bushnell answered SCFRT Committee member questions. Chief Baldwin thanked Ms. Bushnell for her presentation.

Agenda Item 4: Review of 2022 Biennial Report and 2023 Local Child Fatality Review Team recommendations

Chief Baldwin opened the review of the 2022 Biennial Report recommendations and 2023 Local Child Fatality Review Team recommendations for member discussion. The committee reviewed 40 recommendations under the following categories:

- Motor Vehicle Safety seven (7) recommendations;
- Child Abuse Prevention four (4) recommendations;
- Drowning Prevention five (5) recommendations;
- Suicide Prevention:
 - Lethal Means Restriction five (5) recommendations
 - o Mental Health Services ten (10) recommendations
 - Texas Department of Family Protective Services (DFPS) one (1) recommendation;
- Safe Sleep three (3) recommendations; and
- Other Recommendations five (5) recommendations.

After careful discussion and deliberation, the SCFRT Committee selected the following recommendations for the 2024 SCFRT Committee biennial legislative report:

- Three (3) suicide prevention / mental health recommendations;
- One (1) safe sleep recommendation; and
- One (1) general (other) recommendation.

Chief Baldwin called for a motion. Dr. Murthy made a motion to approve the select recommendations with edits discussed. Ms. LaViza Matthews seconded it.
