Entity No Reportable Data	All EMSTR users	Provides a dashboard of months with "no reportable data" (NRD) attestations for a facility / agency.	I want to check a facility/ agency successfully submitted NRD reports and for which months.
Entity Reference Codes Reports	All EMSTR users	Lists all facilities/ agencies, their DSHS IDs, and other basic information for putting into Patient Care Reports (PCR)/ data logs/ records.	I want to search for a facility / agency to find its DSHS Identification number (ID) number, address, and zip code.
EMS Records Submitted by PSAP Report	EMS users	Provides total record counts submitted on the Public Safety Answering Points (PSAP) call time relative to dispatch date.	I want to review how many successful submissions an EMS provider or agency made for each month.
Hospital Admission Report	Hospital users	Provides total record counts with line details for DSHS ID, entity name, and groups batch submissions by month of the patient's hospital admission.	I want to check if there are any gaps or missing data in a facility's submissions.
EMS Records Submission Report	EMS users	Provides total submitted record counts for an EMS agency by submission date and user.	I want to check the date of a facility's / agency's last submission. I want a list of a facility's / agency's recent submissions and their submission date.
Hospital Records Submission Report	Hospital users	Provides total submitted record counts for a hospital facility by submission date and user.	I want to check who completed submissions for a facility / agency.

EMS Data Validity Report	EMS users	Compiles aggregate data (listed by county) monthly, quarterly, and yearly by individual element and element group and valid responses.	I want to sort and analyze patients record completion by certain variables and our performance.
Hospital Data Validity Report	Hospital users	Includes record counts, percentage of valid, valid null, and invalid records for specific element groups.	
EMS Patient Care Report	EMS Users	Provides a line listing of all patient cases submitted for a specific facility / agency during a specified timeframe.	I want to check all patients from a facility / agency have records in EMSTR.
			I want to know the total number of patients at a facility during a specified timeframe.
Trauma Care Report	Hospital users	Provides a listing of all patients admitted to a facility for a given year and their primary injury, among other characteristics.	I want to look up the record, or confirm receipt, of a specific patient.
EMS Custom Report	EMS Users	Provides a comparison of an agency's request time against statewide averages, with filters including incident type and day of the week.	I want to understand how an agency's response time compares to statewide averages.
Trauma Aggregate Data Report	Hospital users	Provides insight into aggregate case counts by entity ID for facilities or regions with the option to include different variables. Listed by county.	I want to sort and analyze patients records by certain variables.
