How to Read the EMS or Hospital File Upload Report

Example of error message:

Exception: Record 6481112_123456, line 2, case will not be saved due to missing or invalid values in the following required fields: TRAUMA REGISTRY NUMBER (TRNO)

How to read the error message:

Exception	This is an error.
Record 6481112_123456	The DSHS ID# assigned by the Injury Program for each entity.
Record 6481112_123456	The Trauma Registry Number for Hospital File Uploads or the Run Report ID number for EMS File Uploads.
line 2	The number of the row from the file that was uploaded.
case will not be saved due to missing or invalid values in the following required fields	A record will not be created in the EMS/Trauma Registry for this patient because one of the MANDATORY data elements is either blank or has an invalid value (check data dictionary to see the MANDATORY data elements, dshs.texas.gov/injury-prevention/ems-trauma-registries).

Example of a 2nd error message for the same record:

Exception: Record 6481112_123456, line 2, required field TRNO must be a numeric value between 1 and 9999999, not 123456

required field TRNO must be a numeric value between 1 and 9999999	Describes the range of values that are valid and the length of the data element is 7 digits (9999999)
not 123456	Gives the value that was reported and that is incorrect (the length is 6 digits and in this record there is a single space after the 6 digit number that should not be there).
