Introduction

Purpose

This user guide is to aid industrial radiographer certification applicants with the application process for the several types and forms of certification applications and applying to take a certification exam.

Definitions

RAS-VO – This user guide is to aid industrial radiographer certification applicants with the application process for the several types and forms of certification applications and applying to take a certification exam.

Overview

Industrial radiographers work with large activities of radioactive materials that can be dangerous to people if they are not handled and stored properly. The certification process is used to ensure that industrial radiographers have had adequate training and experience to safely use these radioactive materials.

Requirements

The requirements for Industrial Radiographer certifications are identified in 25 TAC §289.255(e) Requirements for Qualifications of Radiographic Personnel.

There are three levels of certification for industrial radiographers. These levels are Radiographer Trainee, Radiographer, and Radiographer Trainer.

• Industrial Radiographer Trainee (online application)

Where to take the Exam

The exams are online exams administered at Pearson Vue testing centers, or at one of their contracted testing centers. You will need to bring a government-issued photo identification in order to take the exam.

Exam Payment

Next Steps

Upon receipt of the exam application and payment, we will review the information and payment for any missing information. When we approve you to take the exam, we will notify you and Pearson Vue that you are eligible to take the exam. Pearson Vue will email you instructions on how to select and schedule the most convenient testing center location and time for you. Please note at this time Pearson VUE will assess a \$50.00 exam sitting fee that you will be able to pay online.

After you complete the exam, we will review your exam results and notify you of your score.

Renew Industrial Radiographer Certification Application

Getting Started

To renew your industrial radiographer certification, you will need to retake and pass the exam applicable to your certification.

The exam application process currently must be completed offline. You will need to download a copy of the application form RC 255-3 "Application for Industrial Radiography Examination." On the form, select the check box that is for a "recertification exam".

After you complete the exam, we will review your exam results and let you know your score. If you successfully pass the exam, we will issue you a new Industrial Radiographer card.

Initial Industrial Radiographer On-The-Job (OJT) Application

Getting Started

The initial radiographer application process currently must be completed offline. Use Form RC 255-R "Radiographer Qualification Application OJT (hours)" if you are documenting your on-the-job training in hours.

Use Form RC 255-OS "Radiographer Qualification Application OJT (years)" if you are documenting your on-the-job training by dates.

In addition to meeting the on-the-job training, you must have completed the 40-hour training course covering the topics required in 25 TAC 289.255(x)(1) and passed the examination applicable to the types of use requested.

Reciprocity license applications are moving online. Reciprocal recognition is completed by either a paper application or email submission. This will change to an online service in the future.

Exam Application

Exam applications for licensing are moving online. Exams and the exam application are currently completed by paper application accompanied with the fee payment. This will change from a paper-based service to an online service in the future.

Address Change

Address changes are currently completed by paper or email to <u>IndRadCertification@dshs.texas.gov</u> but will be available to change online in the future.

Payments

Payments are currently submitted by mail as paper checks or money orders. Payments will change from a paper-based service to an online service in the future with the application.
