#### School Reports: Epinephrine Auto-Injectors and Asthma Medication

Texas schools must report to the Texas Department of State Health Services (DSHS) the administration of unassigned epinephrine auto-injectors and unassigned asthma medication. ## Webinar: Addressing the Impact of ACES in Children with Intellectual and Developmental Disabilities

Join Texas Health and Human Services Commission (HHSC) <u>Office of Disability</u> <u>Prevention for Children</u> on December 15, 2022, from 10-11:00 a.m. for a free, live <u>webinar on the impact of adverse childhood experiences (ACES) in children with</u> <u>intellectual and developmental disabilities (IDDs</u>). Children with IDDs are at a higher risk for ACES, which put a child with an IDD at a higher risk of developing mental health conditions and other challenges that may last a lifetime. This webinar examines the role care givers can play in addressing childhood trauma and preventing negative health outcomes among children with IDDs. This webinar is intended for parents, providers who work with families, and others caring for infants and children.

## **Funding Opportunities**

#### Texas Education Agency (TEA) 2023-2025 Charter School Program (Subchapter C and D) Grant

The TEA has announced available funds for the <u>2023-2025 Charter School Program</u> <u>Grant</u>. The purpose of the Texas Quality Charter Schools Program Grant is to support the growth of high-quality charter schools in Texas, especially those focused on improving academic outcomes for educationally disadvantaged students. This will be achieved through administering the 2023-2025 Charter School Program Grant (Subchapter C and D) to assist eligible applicants in opening and preparing for the operation of newly authorized charter schools and replicated high-quality schools. <u>Notice of Intent to Apply</u> is due by December 15, 2022. Submit the full application to the TEA by January 13, 2023. Read the <u>full program guidelines</u> for more information.

## Asbestos Hazard Emergency Response Act (AHERA) Program

AHERA is a federal law that helps protect students, their families, educators, and staff from exposure to asbestos in schools. A primary principle of AHERA is "in-place" asbestos management. AHERA requires schools to inspect suspected Asbestos-Containing Building Materials in all school buildings, develop an Asbestos Management Plan for each school, maintain records, and more.
