School Bus Rebates: Clean School Bus Program

The Environmental Protection Agency (EPA) is offering <u>rebates to replace existing</u> <u>school buses</u> with clean and zero-emission models. Public school districts, charter schools, and others responsible for maintenance of public school buses are eligible to apply.
