The <u>Texas Commission on Environmental Quality (TCEQ)</u> is accepting applications for the 2023 Texas Environmental Excellence Awards. These awards recognize achievements in environmental preservation and protection. Citizens, communities, and organizations can apply to receive the state's highest environmental honor. Education, youth, and civic/community are among the ten award categories. #### Learning Collaborative to Address Adolescent Relationship Abuse and Human Trafficking for School-Based Health Centers

The <u>Healing-Centered</u> <u>Approaches to Addressing Adolescent Relationship Abuse and Human Trafficking for</u> <u>School-Based Health Centers Learning Collaborative</u> is for adolescent-serving schoolbased health centers. Participants will build capacity to promote healthy relationships and prevent adolescent relationship abuse and human trafficking. The collaborative will meet biweekly from October through December. ### **Oliver Foundation Healthy Choices Grants**

The <u>Oliver Foundation's</u> goal is to encourage children, families, and communities in Texas to improve eating and physical activity patterns. The Oliver Foundation has several Healthy Choices grants available for schools ranging from \$750 to \$5,000. The grants require physical activity and nutrition education components. Grant

### **Tobacco Education Resources for Parents and Teachers**

The Food and Drug Administration (FDA) collaborated with the American Academy of Pediatrics to develop a video series on youth tobacco use. Pediatricians answer questions about youth nicotine addiction and cessation resources. The website includes tobacco education resources for parents and teachers. #### **Every Kid Outdoors**

The National Park Service has an <u>Every Kid Outdoors</u> initiative for fourth-grade students. Teachers can submit requests for all fourth-grade students to receive a free National Park Pass. The pass is valid from September 1, 2022 – August 31, 2023. There are also activities and resources to use with students to learn about the parks. Use this resource to encourage students to stay active and learn about the environment.

#### **Counseling, Psychological and Social Services Texas School Mental Health Resource**

The Texas Education Agency, Advancing Wellness and Resiliency in Education, and the University of Texas at Austin Texas Institute for Excellence in Mental Health partnered to create the <u>Texas School Mental Health website</u>.
