#### **2002 Indicators of Inpatient Care in Texas Hospitals**

THCIC will release the 2002 Indicators of Inpatient Care report in May 2004. Hospitals will be given the opportunity to review and/or comment on the report prior to its release. THCIC will mail letters to the THCIC hospital primary contact on January 26<sup>th</sup> and will provide each hospital with information allowing access to a restricted website for viewing the data in the report. This site will be available for access beginning February 2, 2004 and ending April 1, 2004. Questions regarding access may be directed to Dee Shaw at 512-458-7261 ext 3374.

#### **Questions Answered**

Some 20 individuals representing hospitals, vendors and trade associations attended a Questions and Answers session in Austin on January 13<sup>th</sup>. The purpose of the session was for THCIC to respond to questions on the transition to the THCIC 837 claim format. While most questions were technical in nature, the group discussed over fifty questions that had been submitted to THCIC. #### **Hospital Data Collection Workgroup**

In September 2003, all THCIC Technical Advisory Committees were abolished by HB2292, which was a concern for stakeholders as well as THCIC. In order to continue with hospital/stakeholder input, THCIC is creating the **Hospital Data Collection Workgroup** (HDCW). HDCW is a workgroup of stakeholders, health data experts and other people interested in hospital data collected and reports disseminated by the Hospital Discharge Data Program.

HDCW meetings will be posted on the THCIC and the Center for Health Statistics Websites and will be held in Austin. The group will be consulted on changes in hospital data collection and reporting.

Persons interested in participating on the HDCW should send an e-mail by **February 6<sup>th</sup>** to <u>dee.shaw@tdh.state.tx.us</u> with the following information: Name, organization w/address, position, e-mail address, phone number, and a very brief description on your health data background. The e-mail "subject" line should indicate "**Hospital Data Collection Workgroup Applicant**".

Please note that applicants selected to serve as a member of the HDCW will be required to attend meetings held in Austin, and teleconferencing will not be an option. Members will be responsible for their travel expenses and will not be entitled to reimbursement from THCIC. The first HDCW meeting is targeted for early March 2004.

#### 4q2002 Public Use Data File (PUDF)

Since the release of the 4q02 PUDF (dated December 2003) in January 2004, an error was discovered in the primary source of payment fields and a format change was discovered in the DRG fields. These errors have been corrected and THCIC is in the process of mailing out the corrected CDs to purchasers. The corrected 4q02 PUDF CD will be labeled with a date of February 2004 and will include a description of what was changed/corrected.

Purchasers of the 4q02 PUDF should contact Dee Shaw at <u>dee.shaw@tdh.state.tx.us</u> if they have not received the corrected CD by the 15<sup>th</sup> of March 2004.

#### **UB92T To Be Accepted Through December 31, 2004 By THCIC**

As a result of the January 13 Questions and Answers session and subsequent discussions with hospitals, vendors, and trade associations, the transition to the THCIC 837 format has been revised to allow for the submission of the UB92 for claims through December 31, 2004. Because some hospitals are already submitting data in the THCIC 837 format, the UB92Transition format that is being accepted is a slightly revised version of the UB92 to allow for all claims to be processed as if submitted in the THCIC 837 format. These UB92T claims are UB92 version 6.0 with these two modifications:

- 1. The 6-digit THCIC ID **must** be placed in the data element "Other Insurer Provider #2" [record 10, field 10, columns 74-86].
- 2. The data element "Receiver Identification" [record 01, field 6, columns 32-36] **must** contain the value "TH837".

These modifications must be made for the UB92T claims to be processed. Claims submitted in the UB92T format will be processed as follows:

1. Claims Translation:

UB92T claims will be translated into THCIC 837 claims for processing.

2. Data Translation:

Standard Source of Payment and Non-Standard Source of Payment code values will be translated into the Claim Indicator Source Code.

3. Audit:

UB92T claims will be subjected to the THCIC 837 audits.

#### 4. Claims Correction:

Hospitals may submit claims corrections using the UB92T claim or use the new THCIC 837 Data Correction Software.

#### 5. Certification:

Hospitals will use the new THCIC 837 Certification Software.

Hospitals are encouraged to submit data in the THCIC 837 format as quickly as possible to take advantage of the expanded numbers of diagnosis, procedures, and e-codes. When data for year 2004 are released, each record will include an indicator of the format in which the data were submitted. Hospitals must continue to make a good faith effort to transition to the THCIC 837 format to not be penalized by THCIC. All claims must be submitted in the THCIC 837 format by January 1, 2005.

#### **Certification of Data**

Effective November 1, 2003, THCIC no longer provides the Certification and/or Error files to hospitals on diskette or CD-ROM. Hospitals must dial in by modem to retrieve the files from an electronic mailbox located at Commonwealth Clinical Systems (CCS). Hospitals not wishing to use this method of retrieving the Certification and/or Error files, may contact CCS at 888-308-4953 to request the files on diskette or CD-ROM at the hospitals expense.

It is the hospitals responsibility to retrieve the Certification and/or Error files. Please note that not submitting a Certification Letter for each quarter/year is punishable by a civil penalty.

### DO NOT SUBMIT YOUR 2004 SERVICES UNLESS YOU CAN SAY YES TO ONE OF THE FOLLOWING...

You are submitting in the THCIC 837 claim format and have completed testing with THIN

Or

You have made the two changes to your UB92 claim format necessary to submit 2004 data.

#### **UB92T To Be Accepted Through December 31, 2004**

### Hospitals now have more time to prepare for submitting their claims in the THCIC 837 format

In case you didn't get the previous Numbered Letter: The due date for submitting THCIC 837 claims has been extended to December 31, 2004. However, this is a drop-dead date and is fixed – not tied to the service date.

In order to continue to submit UB92 claims, hospitals **must modify their claims format to meet the UB92T** ransition requirements. The UB92T format requires very minor changes to the existing UB92 version 6.0. The required changes allow for all claims to be processed as if submitted in the THCIC 837 format.

To create a valid UB92T claim, make the following two modifications to your UB92 version 6.0:

- 1. The 6-digit THCIC ID <u>must</u> be placed in the data element "Other Insurer Provider #2" [record 10, field 10, columns 74-86].
- 2. The data element "Receiver Identification" [record 01, field 6, columns 32-36] <u>must</u> contain the value "TH837".

These modifications must be made for the UB92T claims to be processed. Claims submitted in the UB92T format will be processed as follows:

1. Claims Translation:

UB92T claims will be translated into THCIC 837 claims for processing.

2. Data Translation:

Standard Source of Payment and Non-Standard Source of Payment code values will be translated into the Claim Filing Indicator Code.

3. Audit:

UB92T claims will be subjected to the THCIC 837 audits.

4. Claims Correction:

Hospitals may submit claims corrections using the UB92T claim or use the new THCIC 837 Data Correction Software.

5. *Certification*:

Hospitals will use the new THCIC 837 Certification Software.

#### Don't Be Left Behind in 2004

Hospitals are encouraged to submit data in the THCIC 837 format as quickly as possible to take advantage of the expanded numbers of diagnosis, procedures, and E-codes for their 2004 data. When data for year 2004 are released, each record will include an indicator of the format in which the data were submitted.

#### Only 9 months to January 1, 2005

All claims must be submitted in the THCIC 837 format beginning January 1, 2005, no exceptions. The date is fixed and not tied to the service period. So, in order to avoid the cutover pain, hospitals should begin submitting the THCIC 837 claim format in September to avoid hitting the wall.

#### **Indicators of Inpatient Care in Texas Hospitals, 2002**

The review by hospitals of the data to be included in the 2002 Indicators of Inpatient Care in Texas Hospitals ended on April 1. Comments were received from many hospitals and they will become part of the report. The report is expected to be released in May and hospitals will be notified of the release date when it has been determined.

#### First Quarter 2003 PUDF Release

The Public Use Data File for 1<sup>st</sup> quarter 2003 will be mailed by April 9th to those who have already purchased the file. The file contains data from 445 hospitals on nearly 700,000 discharges. The cost of the file is \$1500 and the entire year can be purchased for \$5000. The cost of the file to reporting hospitals is \$750 and \$2500 for the entire year.

#### **Submitting 2004 Claims**

When you submit 2004 claims, the receiver ID must be "YTH837". If you submit using "YTHCIC" and the services are for 2004, the claims will be rejected.

#### **Important Information for 837 Submitters**

#### **Testing**

For those that have submitted 837 tests to THIN:

THIN expects to complete review and approval of test submissions that it has received to date by the end of this month. You should either receive an "approved for production" notice or documentation regarding issues that need to be resolved.

#### For those that are scheduled to submit 837 tests to THIN:

- Make sure you notify them that you are sending a test submission. It has to be hand worked and with all of the data they receive it might fall through the crack.
- The turnaround on the initial review is 3 business days. If you don't hear anything contact the THIN EDI Helpline at (972) 766-5480.

#### A New Acknowledgement Report from THIN

The acknowledgement reports from THIN include an additional report for 837 submissions. This report, the 997 acknowledgement, describes the results of the translator program that THIN uses to translate your 837 submission for further processing. This report is actually a data file that reports any status (and any errors) that the translator program encountered. You can identify the 997 report in that the file name ends in .997.

If the translator had serious problems, then most likely it did not release any data for processing. If this happens, there will be no other reports, such as a Claim Acceptance Response Report (\*.RSP).

If the translator didn't have serious problems, then there will be the RSP report.

As in the past, you should receive your RSP report within 24 hours.

To determine if you should receive a RSP report, you need to check the 997 report. It is relatively easy to determine if the translator rejected your submission.

The 997 report contains lines of numbers and letters. Look through the lines for AK5|. Immediately behind this is a one-character value that summarizes what the translator did. The codes are as follows:

A, E The translation was successful.

There should be a RSP report.

If the report is not posted to your mailbox within 24 hours, call the THIN

Helpline (972) 766-5480.

M, R, W, X The translator rejected your submission.

There will not be a RSP report.

Refer the 997 report to the person(s) responsible for your computer system, either the vendor or your IT people, so they can take appropriate

action.

#### **Possible Delay in Processing 2004 Claims Submissions**

Acceptance and processing of 1<sup>st</sup> Quarter 2004 claims may be delayed. As of May 3<sup>rd</sup>, THIN had not completed their quality assurance of test submission as planned. THIN continues to work diligently to complete their efforts. However, in light that neither THCIC 837 nor UB92T claims can be accepted by THIN, THCIC will not issue any penalties if hospitals are unable to successfully submit 1<sup>st</sup> Quarter 2004 claims by June 1, 2004.

1<sup>st</sup> Quarter claims received after June 1, 2004 will be processed with the 2<sup>nd</sup> Quarter 2004 claims and both quarter of claims will be returned to hospitals for correction and review following the 2<sup>nd</sup> Quarter 2004 schedule.

As soon as THIN completes quality assurance, they will begin reviewing 837 test submissions and processing UB92T claims. So, the opportunity exists that some hospitals will have their claims processed into the 1<sup>st</sup> Quarter 2004 cycle.

THCIC regrets this late change, but HIPAA has required flexibility on the part of all of us.

#### **Delay in Processing 2004 Claims Submissions**

Because THIN has not completed their quality assurance of test submission, THCIC will not issue any penalties if hospitals are unable to successfully submit 1<sup>st</sup> Quarter 2004 claims by June 1, 2004.

1<sup>st</sup> Quarter claims received after June 1, 2004 will be processed with the 2<sup>nd</sup> Quarter 2004 claims and both quarters of claims will be returned to hospitals for correction and review following the 2<sup>nd</sup> Quarter 2004 schedule.

As soon as THIN completes quality assurance, they will begin reviewing 837 test submissions and processing UB92T claims. So, the possibility exists that some hospitals will have their claims processed into the 1<sup>st</sup> Quarter 2004 cycle.

THCIC regrets this late change, but HIPAA has required flexibility on the part of all of us.

### Hospitals now have more time to prepare for submitting their claims in the THCIC 837 format

In case you didn't get the previous Numbered Letter: The due date for submitting THCIC 837 claims has been extended to December 31, 2004. However, this is a drop-dead date and is fixed – not tied to the service date.

In order to continue to submit UB92 claims, hospitals **must modify their claims format to meet the UB92T** ransition requirements. The UB92T format requires very minor changes to the existing UB92 version 6.0. The required changes allow for all claims to be processed as if submitted in the THCIC 837 format

To create a valid UB92T claim, make the following two modifications to your UB92 version 6.0:

- 1. The 6-digit THCIC ID <u>must</u> be placed in the data element "Other Insurer Provider #2" [record 10, field 10, columns 74-86].
- 2. The data element "Receiver Identification" [record 01, field 6, columns 32-36] <u>must</u> contain the value "TH837".

These modifications must be made for the UB92T claims to be processed. Claims submitted in the UB92T format will be processed as follows:

#### 1. Claims Translation:

UB92T claims will be translated into THCIC 837 claims for processing.

#### 2. Data Translation:

Standard Source of Payment and Non-Standard Source of Payment code values will be translated into the Claim Filing Indicator Code.

#### 3. Audit:

UB92T claims will be subjected to the THCIC 837 audits.

#### 4. Claims Correction:

Hospitals may submit claims corrections using the UB92T claim or use the new THCIC 837 Data Correction Software.

#### 5. *Certification*:

Hospitals will use the new THCIC 837 Certification Software.

#### Indicators of Inpatient Care in Texas Hospitals, 2002

The Texas Health Care Information Council will release to the public *Indicators of Inpatient Care in Texas Hospitals*, 2002 on Wednesday, June 30, 2004. The report again uses Agency for Healthcare Research and Quality (AHRQ) Inpatient Quality Indicator (IQI) methodology to provide a window into the quality of care provided in Texas hospitals. The report will be available on the THCIC website, not in printed form. THCIC, through the Texas Department of Health, will issue a press release on the availability of the report.

The report will appear on THCIC's website much the same as it did for THCIC's release of 1999-2001 data last year. The report will include data for 2002 in tables and bar charts for each of the 25 indicators. The searchable database will include data for 1999-2002 and will allow users to see each hospital's performance for the entire four-year period.

#### 2<sup>nd</sup> Quarter PUDF Release

The Public Use Data File for second quarter 2003 will be released next week and will be sent to those users who have requested it. The file can be purchased for \$750 by participating hospitals and for \$1500 by all other users. The file includes records for over 696,000 inpatients discharged by over 440 hospitals during April, May, and June of 2003.

#### **Use of Username and Submitter ID**

#### **Social Security Number and UB92T Submissions**

It has been brought to our attention that during the transition to the THCIC 837 claim format, the audit for a missing SSN on the UB92T may require additional software changes for those winding down from the UB92T. The intent is that there not be additional changes above those initially identified so that focus could remain on transitioning to the THCIC 837 claim format. Therefore, spaces will be allowed in the SSN field when data is submitted in the UB92T format. When submitting in the THCIC 837 format, SSN's are required and all 9's should be used when no SSN is available. Each SSN that is received will be checked for validity under the current guidelines and criteria previously established.

#### **UB92T Submission Address**

The process for identifying hospitals' data by automation includes matching several data fields from the Record 10 (UB92T). The identifiers include the hospitals' **Tax ID Number**, **Submission Address**, and the **THCIC ID Number**. If these fields do not match, the data cannot be identified.

The majority of the test data (UB92T format only) that have been submitted are not matching for identification due to the **Submission Address**. A list of Submission Addresses for each submitting hospital has been posted on the THCIC web site at <a href="http://www.thcic.state.tx.us/hospitals/Hospital Liaison.PDF">http://www.thcic.state.tx.us/hospitals/Hospital Liaison.PDF</a>. Please verify your hospitals Submission Address and make the necessary corrections to your UB92T submission file; we strongly recommend you contact your IT department or vendor to verify what they are submitting on the file for your facility, sometimes it is abbreviated badly, has an old address, or is typed in differently than what THCIC has in the reference file. Any modification in these data elements on the file cause the file to be manually identified and may slow the processing of your data. If the Submission Address listed on the THCIC web site is incorrect, please contact Dee Shaw at dee.shaw@tdh.state.tx.us.

#### **Data Submission Format Issues**

#### **Character sets and Line control**

- 1. **Data must be in ASCII** (American Standard Code for Information Interchange) **format**. EBCDIC (Extended Binary Coded Decimal Interchange Code) and Hex (hexadecimal) codes cannot and will not be processed.
- 2. Data files should only contain the following control characters:
  - a. **CR** (*Carriage Return The ASCII character moves the cursor to the left margin. It is often used to begin a new line of output on the line below*), and
  - b. **LF** (*Line Feed-The ASCII character which moves the cursor down to the same column on the next line*)

#### **ZIP Files**

- DO NOT PASSWORD PROTECT ZIPPED FILES FOR <u>DIAL-UP AND UPLOAD</u>.
   All zipped files uploaded by the dial up process (HyperTerminal, Kermit, etc...) should not be password protected.
- 4. PASSWORD PROTECT ZIPPED FILES THAT ARE SENT BY MAIL ON <u>CD OR</u> <u>DISKETTE</u>. Use your <u>submitter password</u> that was assigned by CCS. Make sure the password is in <u>lower case</u> letters.

#### **HELPDESK Preferences for troubleshooting errant files**

5. For 837 format submissions, have each segment on its own line. This requires that each segment separator (e.g. "~") be followed by a CR or LF.

For UB92T format submissions, have each record of 192 bytes/characters on its own line. THCIC recommends that a CR <u>and</u> a LF (not just a line feed) follow each segment separator (e.g. "~").

#### 45% of Enrolled Submitters Still Need to Test

THCIC has enrolled 135 submitters and 61 have not submitted a test file as of August 31<sup>st</sup>. It is very important for submitters to test their submission process as soon as possible, as it takes approximately 3-5 days for THCIC to review the test submission. Submitters will have an acknowledgement (of the receipt of the file submission) in their submitter mailbox within 24-48 hours. A second notice will available in the submitter's mailbox once submission has been reviewed.

#### 1st and 2nd Quarter 2004 Claims Due October 1, 2004

#### **THCIC 837 Extension Offered**

Hospitals submitting claims using the **THCIC 837 claim format** that have not completed testing for 837 submission will be allowed to delay submission of 1st and 2nd quarters 2004 to the December 1<sup>st</sup> cutoff for 3<sup>rd</sup> quarter claims. However, hospitals and/or their submitters must submit all three quarters of 2004 no later than December 1, 2004.

To be eligible for this schedule extension, hospitals and/or their submitters/vendors must have submitted 837 claim tests prior to October 1<sup>st</sup> and must demonstrate progress toward a successful test.

If hospitals wish to request the schedule extension for **THCIC 837** format only, they should contact Dee Shaw via email at dee.shaw@dshs.state.tx.us.

Hospitals submitting claims using the **UB92T claim format** that have submitted test claims prior to October 1<sup>st</sup> and are waiting for production approval will not be penalized as long as the production claims are submitted within 24 hours of receiving production approval from CCS.

Hospitals that have not submitted test files (THCIC 837 or UB92T) prior to October 1<sup>st</sup> will be considered out of compliance and may be subject to penalty.

#### CCS Ready to Accept Data by FTP

Data can now be submitted to CCS and files can be retrieved from CCS using File Transfer Protocol (FTP). Go to http://www.thcichelp.com/ftp.htm for the procedures to follow.

Data submitters must use FTP software to connect to the computer at CCS via the Internet. FTP software can be found using Google or Yahoo search engines and downloaded. Choose one that works for you.

Data submitters must also use encryption software to transmit protected health information over the Internet. A Google or Yahoo search will find numerous sites where this software can be obtained free or for a reasonable price. A couple of strong encryption programs are Pretty Good Privacy (PGP) <a href="http://www.pgp.com">http://www.pgp.com</a>, \$59 for a personal desktop license, and GNU Privacy Guard (GPG) <a href="http://www.gnupg.org">http://www.gnupg.org</a>, available for download free of charge. The encryption software will convert text (your data files) into ciphertext (encrypted data) so that only the intended receiver can read the data. This process requires that keys be passed between the data submitter

and the receiver (CCS) before data submission. The keys are needed by the submitter to encrypt the data and for CCS to decrypt the data after it is received.

#### **UB92T Claim Submission**

The 3-character THCIC Code is NO LONGER VALID. It has been replaced by the 6-digit THCIC hospital Identifier in record 10, field 10.

#### **Hospital Procedures and Technical Specifications Manual Update**

A new update, #12, of the THCIC Hospital Procedures and Technical Specifications manual is available on the THCIC website. To better accommodate the different users of the manual, the main manual has been separated into three parts - Hospital Procedures, THCIC 837 Technical Specifications, UB92T Technical Specifications.

The Hospital Procedures are still a work in progress as not all of the changes reflecting the switch from THIN and the new procedures at CCS are in place.

The THCIC 837 Technical Specifications manual reflects the submission specifications, as we know them today. More work is still needed to finalize copyright protections but the specifications are up-to-date. (All data submissions must be in the THCIC 837 format by January 1, 2005)

The UB92T Technical Specifications manual is complete and has been separated, as this manual will not be with us much longer. (UB92T format will not longer be accepted after December 31, 2004)

The Appendices are being finalized today to remove some references to THIN, but code sets are as up-to-date as we know them to be.

And finally, the updates section is being revised in light of the new manual format. This will happen over the next week or so.

#### **Hospitals May Face Penalties**

Although THCIC has extended the timeline for the submission of 1<sup>st</sup> and 2<sup>nd</sup> quarter 2004, there are a few hospitals that have not begun "testing" for the submission of production data. Those hospitals will face a penalty for non-compliance. Non-compliance notices will be mailed out to those hospitals.

#### **HCPCS Revenue Procedure Codes Updated**

During the testing and data submission process for the THCIC 837 format, error (#672 – Invalid Revenue Procedure Code) is being detected for a couple of known reasons.

- 1. Providers are using an incorrect qualifying code for Revenue Codes "0022" and "0024", which are the revenue codes associated with prospective payment systems for SNF and IRF, in the SV201 location. The cause is the use of "HC" for HCPCS instead of "ZZ" for HIPPS codes in the SV202-1 segment. Since this is the incorrect qualifier for the code, error #672 is assigned to the data element, even though there is a valid HIPPS code.
- 2. The THCIC reference file was missing some HCPCS codes that were reinstated by CMS. These are listed in Hospital Numbered Letter; Volume 7 Number 17 dated October 14, 2004 and are listed again below. If you are using the THCIC Data Correction Software (DCS) you can contact the THCIC HelpDesk (888) 308-4953 or <a href="www.thcichelp.com">www.thcichelp.com</a> and get the password and SQL statement to mark these errors as corrected and upload those data records/claims. After re-processing, any existing errors will be returned.

#### **Use Your Submitter ID and Password for Original Data Submission**

Commonwealth Clinical Systems, Inc. (CCS) is receiving a lot of correction files uploaded to submitter mailboxes, and even more submissions being uploaded to provider mailboxes. In order to eliminate liability, CCS will no longer manually relocate these files. Files uploaded to the incorrect mailbox will need to be retransmitted.

- Original/first submissions must be uploaded to the Submitter mailbox (thsub###).
- **Corrections** (Error correction data from Data Correction Software) and **comments for Certification** must be uploaded to the **Provider mailbox** (th#####).

#### Naming of Files

Many Submitters are uploading a file named 'Claims.dat', probably because this is the name of the extract produced by their software. CCS highly recommends that submitters use a unique file name for every upload. When all submission files are named the same, it can be difficult for the submitter to identify what file is referenced in the submission receipt. Make things easy for yourself by naming your file with the quarter and year plus your identifier (e.g. SUB###\_1Q2004.dat or (THCIC ID #) ######\_2Q2004.txt).

## All Claims Submissions must be in the THCIC 837 Format Beginning January 1, 2005

Effective January 1, 2005, all claims must be submitted in the THCIC 837 claim format regardless of the service date of the claims. **UB92T claims will not be accepted after** 12/31/2004. If your vendor has not begun testing the THCIC 837 claim format, you should contact them because <u>you</u>, not your vendor, are responsible to THCIC for not submitting on time.

#### **Hospitals May Face Penalties**

Although THCIC has extended the timeline for the submission of 1<sup>st</sup> and 2<sup>nd</sup> quarter 2004, there are a few hospitals that have not begun "testing" for the submission of production data. Those hospitals will face a penalty for non-compliance. Non-compliance notices will be mailed out to those hospitals.

#### **Error Code 672**

Are you receiving error code 672 on the audit response reports? This audit is being triggered in many submissions and indicates an invalid revenue procedure code. We find three main reasons for the error:

- 1. For Prospective Pay claims for SNF and IRF, where revenue codes 0022 and 0024 are used, an incorrect qualifier is being used for the HIPPS codes. The qualifier for Prospective Pay should be "ZZ". In many cases, the qualifier that indicates a HCPCS code follows, "HC", is being used. Since this is the incorrect qualifier for a HIPPS code, the audit fails, even though there is a valid HIPPS code.
- 2. The THCIC reference file was missing some HCPCS codes that were reinstated by CMS. These have been added and any future auditing runs will include those audits.
- 3. One or more codes used by the hospital are out-of-date. That is, they were but are no longer active.

If you receive a high volume of error 672 and you are using the THCIC Data Correction Software (DCS) you can contact the THCIC HelpDesk (888) 308-4953 or <a href="www.thcichelp.com">www.thcichelp.com</a> and get the password and SQL statement to mark these errors as corrected and upload those data records/claims. After re-processing, any existing errors will be returned.

#### **Things That Will Help The Transition Go Smoother**

#### If you are submitting for yourself ----

If your hospital is submitting claims for itself, then you have two IDs, one for submitting data and one for corrections and certification. The submitter ID (starts with SUB) must be used when you are submitting data in the 837 (or UB92T) format to Commonwealth. The hospital ID (6 numbers) is used with corrections and certification.

The reason for the two numbers is that the submitter ID can be used to submit data for one or more hospitals, while the hospital ID is particular to only one hospital.

When uploading data to Commonwealth, the mailbox name is either the submitter ID or the hospital ID preceded by "th" (thsub*nnn* or th*nnnnnn*). Either ID can be used.

In summary –

- **Submissions** (837 or UB92T claims) must be uploaded to the **Submitter mailbox** (thsubnnn).
- Corrections (from Data Correction Software) and comments for Certification must be uploaded to the Provider mailbox (thnnnnn).

#### File Names

Many submitters are uploading a file named 'Claims.dat', probably because this is the name of the extract produced by their software. Commonwealth requests that submitters use a unique file name for every upload. When all submission files are named the same, it can be difficult for the submitter to identify which file is referenced in the submission receipt. Make things easy for yourself by naming your file with the quarter and year plus your identifier (e.g. SUB### 1Q2004.dat or (THCIC ID #) ###### 2Q2004.txt).

#### CERTIFICATION FOR 1st and 2nd QUARTER

#### Files Will be Late

The certification files for 1<sup>st</sup> and 2<sup>nd</sup> quarter were not released on 12/15. Current target for release is January 7, 2005. THCIC is doing final quality assurance on the certification data and the new certification software at this time. Once the certification files and certification software is available, due dates for corrections at certification and certification letters will be adjusted as needed. 1<sup>st</sup> and 2<sup>nd</sup> quarter Certification letters will be due at the same time as the 3Q04 certification letter; early submission is encouraged and appreciated.

#### **Quarters issued separately**

The certification files for 1<sup>st</sup> and 2<sup>nd</sup> quarter will be released separately so that hospitals will be able to certify each quarter independent of the other. Hospitals will send in two certification letters.

### REMINDER: All FILE SUBMISSIONS BEGINNING JANUARY 1 MUST BE IN THE THCIC 837 CLAIM FORMAT

Effective with the New Year, all claims submissions must be in the THCIC 837 format, regardless of the service date of the claim. If your submitter has not been approved for 837 production, they should be testing in earnest. Experience to-date shows that the new format may require several passes in order to get a valid submission. Turnaround for test reviews is around 5 days, which means that there are not many test turnarounds before January 1.

#### **Provider Validation Automated**

THCIC and Commonwealth have completed automation of what was previously a manual process, that being provider identification. With the transition to the UB92T and the 837, THCIC now has available the final piece of data that allows for completion of automation of the validation.

THCIC uses a combination of three data elements to ensure the validity of providers; those being the 6-digit THCIC hospital ID, the 1<sup>st</sup> fifteen characters of the Provider street address and the Provider's EIN. If there is not a match on all three data elements, the submission will be rejected back to the submitter. New audits have been created for each of the possible data element mismatches.

Submitters that encounter a provider identification rejection should ensure that the provider data they are submitting is the same as recorded at THCIC. This can be validated by contacting Dee Shaw at dee.shaw@dshs.state.tx.us.
